Land violations committed in April 2017

Date	Time	Nature of violation
6 April	1000	From inside occupied Palestinian territory at the Shaykh Abbad position opposite the town of Hula, members of an Israeli enemy patrol pointed a machine gun and the cannon of a Merkava tank at Lebanese civilians on the Lebanese side.
11 April	1945 2015	Opposite the town of Abbasiyah-Ghajar, an Israeli enemy patrol comprising two Hummer vehicles inspected the barbed wire fence and directed a searchlight towards Lebanese territory.
14 April	1127 1200	Opposite the town of Yarun near point W420A, the Israeli enemy pointed the cannon of a Merkava tank at an Observer Group Lebanon patrol stationed inside Lebanese territory.
24 April	1000	Inside occupied Palestinian territory, opposite the town of Alma al-Sha'b, a wheeled bulldozer and two Israeli enemy trench-diggers crossed the technical fence, without violating the Blue Line and worked on the road between points B11 and B13. At 1025 hours, Israeli enemy soldiers pointed their personal weapons at a Lebanese Army patrol, and one of them cocked his weapon at members of the patrol. The work ended at 1715 hours, and the vehicles and soldiers left in the direction of occupied territory.
	1922	On the outskirts of the town of Hula, while three Lebanese civilians were taking a walk and taking photographs opposite the Shaykh Abbad position, an Israeli enemy soldier threw stones at them from that position, without injury. The civilians subsequently left in the direction of the town of Hula.
25 April	0830	Inside occupied Palestinian territory, opposite the town of Alma al-Sha'b, a wheeled bulldozer and two Israeli enemy trench-diggers crossed the technical fence without violating the Blue Line and worked on the road between points B11 and B13. They were escorted by enemy soldiers. The work ended at 1650 hours and the soldiers and vehicles left in the direction of occupied territory.
26 April	0915 1000	Several explosions were heard from inside the occupied Shab'a Farms.
	2040 2110	Several explosions were heard from inside the occupied Shab'a Farms.
27 April	0900 2030	Inside the occupied Shab'a Farms in the vicinity of Jabal al-Shahal, the Israeli enemy cut a dirt road towards the Radar outpost using three trench diggers escorted by two Merkava tanks.
	1320	Outside of the town of Shab'a, in the vicinity of Jabal al-Shahal, while the herder Mahir Hamdan was herding a herd of goats, an Israeli enemy patrol comprising nine soldiers crossed the line of withdrawal (the Blue

	2145	Inside occupied Palestinian territory, opposite the Kafr Killa-Udaysah highway, an Israeli enemy patrol comprising four soldiers inspected the technical fence. They pointed and cocked their weapons at members of a Lebanese Army patrol and shouted derogatory language.
