

LOCALIZATION OF CONFLICT INCIDENTS

<u>Note:</u> The following list is an overview of the incident data included in the ACLED dataset. More details are available in the actual dataset (date, location data, event type, involved actors, information sources, etc.). In the following list, the names of event locations are taken from ACLED, while the administrative region names are taken from GADM data which serves as the basis for the map above.

In **Bangui**, 17 incidents killing 23 people were reported. The following locations were affected: **Bangui**, **Bangui** 2e.

In Haut-Mbomou, 1 incident killing 0 people was reported. The following location was affected: Obo.

In Haute-Kotto, 4 incidents killing 50 people were reported. The following location was affected: Bria.

In Lobaye, 2 incidents killing 16 people were reported. The following location was affected: Bambio - Lobaye.

In **Mbomou**, 6 incidents killing 8 people were reported. The following locations were affected: **Agoumar**, **Madabazouma**, **Nzako**, **Rafai**, **Zongo**.

In Ouaka, 2 incidents killing 25 people were reported. The following locations were affected: Kede, Ouambambassa.

In **Ouham**, **4** incidents killing **16** people were reported. The following locations were affected: **Bokayanga**, **Bornou**, **Vafio**.

METHODOLOGY

The data used in this report was collected by the Armed Conflict Location & Event Data Project (ACLED). ACLED collects data on reported conflict events in selected African and Asian countries, Central African Republic being among them. ACLED researchers collect event data from a variety of sources and code them by date, location, agent, and event type. Based on these data, the Austrian Centre for Country of Origin & Asylum Research and Documentation (ACCORD) compiles updates on conflict incidents.

Incidents comprise the following categories: battle, headquarters or base established, non-violent strategic activities, riots/protests, violence against civilians, non-violent transfer of territory, remote violence. For details on these categories, please see
