ON THE FORM OF A DISPLACED-EXPELLED PERSON CARD

Based on Article 8 Paragraph 3 of the Law on Displaced-Expelled Persons and Repatriates in the Federation of Bosnia and Herzegovina (FBH Official Gazette, number 19/2000), Federation Minister for Social Affairs, Displaced Persons and Refugees, in co-operation with other Cantonal bodies in charge of displaced persons, i s p a s s i n g the

I N S T R U C T I O N

ON THE FORM OF A DISPLACED-EXPELLED PERSON CARD

I G E N E R A L P R O V I S I O N S

1. This Instruction prescribes in more details the procedure for issuance and the form of a displaced-expelled person card in the Federation of Bosnia and Herzegovina (hereinafter: the card).
2. Every person whose status of a displaced-expelled person has been recognised with a decision shall be issued the card in accordance with this Instruction.

II I S S U A N C E O F A D I S P L A C E D - E X P E L L E D P E R S O N C A R D

3. The card shall be issued based on the request for recognition of the status which contains: first name (father's name) and last name of the applicant, the address of his/her previous residence, JMBG and the date of leaving the place of his/her previous permanent residence.
4. When submitting the request, the applicant is obliged to complete the form no. 1 prescribed by the Instruction on Keeping Basic and Main Records on Displaced-Expelled Persons and Repatriates for the Territory of the Federation of Bosnia and Herzegovina.
5. The card shall be issued by the competent Cantonal administrative body according to the place of temporary residence of a displaced-expelled person.
6. The card shall be issued on the form no. 2A – the card of a displaced-expelled person prescribed by this Instruction.
7. The card shall contain the following data: first and last name of a displaced-expelled person, the address of his/her previous permanent residence, the address of his/her current temporary residence, ID card number, JMBG, unique code, issuing date and place, signature of an authorised official and signature of the displaced-expelled person.
8. The administrative body referred to in Item 4 of this Instruction shall deliver data about persons who have been issued the card, to the competent municipal Police

Administration according to the place of temporary residence of the displaced-expelled person.

III TRANSITIONAL AND FINAL PROVISIONS

9. Persons who do not replace their cards in accordance with this Instruction within the deadline referred to in Article 33 of the Law on Displaced-Expelled Persons and Repatriates in the Federation of Bosnia and Herzegovina (FBH Official Gazette, no. 19/2000), shall not be able to prove their status of a displaced-expelled person in any other way.

10. The form prescribed by this Instruction is the integral part of the Instruction.

11. This Instruction shall enter into force on the day of its publication in the Official Gazette of the Federation of Bosnia and Herzegovina.
