Based on the Article 64 Para 2 of the Law on Asylum (“Official Gazette of the Republic of Montenegro”, no. 45/06), Ministry of Labour and Social Welfare adopts

RULEBOOK

ON ACCESS TO RIGHT TO ACCOMMODATION FOR PERSON SEEKING ASYLUM, PERSON GRANTED WITH REFUGEE STATUS, PERSON GRANTED WITH SUBSIDIARY PROTECTION OR PERSON GRANTED TEMPORARY PROTECTION

(“Official Gazette of Montenegro”, no. 44/14, dated 21.10.2014)

I GENERAL PROVISIONS

Article 1

This Rulebook stipulates manner of exercising right to accommodation of person seeking asylum, person granted refugee status, person granted subsidiary protection or person granted temporary protection.

Article 2

Facility in which persons referred to Article 1 of this Rulebook are accommodated shall meet the requirements stipulated by the urban-planning, construction, technical, sanitary, fire-safety and environmental regulations.

II ACCOMMODATION OF PERSON SEEKING ASYLUM

Article 3

Person seeking asylum is accommodated in the Center for Accommodation of Asylum-Seekers (hereinafter: Center) or other facility for collective accommodation.
Conclusion shall be adopted on accommodation and discontinuance of accommodation of person seeking asylum.

Article 4

Upon arrival to the Center or other facility for collective accommodation, hygienic and health examination of person seeking asylum shall be conducted, followed by monitoring of health condition based on epidemiological indication, in line with health regulations.

Article 5

If there are no justified reasons (lack of accommodation capacities in the Center, temporary inoperability of the Center for the maintenance etc.), person seeking asylum can be accommodated in other proper manner.

Person seeking asylum can, depending on the nature of their needs and situation, be situated in a safe house, psychiatric institution or adequate institution of social and child protection, in accordance with law.

Article 6

At the Center or other facility for collective accommodation a separate accommodation shall be ensured for males and females who are not part of a same family, as well as for persons belonging to various vulnerable categories.

Article 7

Unaccompanied minor shall be accommodated in the premises suitable for minors.

Exceptionally, a person referred to in Paragraph 1 of this Article, taking into consideration their best interest, can be accommodated jointly with their adult siblings or their elderly relative.

Article 8

Single woman and single parent with children shall be accommodated separately from other persons.

Article 9

Person seeking asylum shall be provided with accommodation suitable to their needs, health protection and psycho-social support, with particular respect to persons with specific needs.

Article 10

Person seeking asylum is obliged to abide the rules of residence at the Center or other facility for collective accommodation, which are stipulated by the House Rules.

Article 11

Person seeking asylum, accommodated in the Center or other facility for collective accommodation is entitled to three meals per day.

Person with special dietary needs is entitled to meals, suitable for their health condition and special needs.

Content and type of food referred to in the Paragraph 2 of this Article shall be determined based on recommendation from attending physician.

Minor under the age of 14, alongside with meal entitlements referred to in the Paragraph 1 of this Article, shall be provided with morning and afternoon snack, while a minor above the age of 14 shall be provided only with afternoon snack.

Article 12

During their stay in the Center or other facility for collective accommodation, person seeking asylum will be provided with basic hygiene necessities and necessary clothes and footwear.

Basic hygiene package (necessities) is provided to the person seeking asylum upon his admission into the Center or other facility for collective accommodation.

Basic hygiene package referred to in the Paragraph 2 of this Article contains: soap, shampoo, toothpaste, toothbrush, shaving foam, shaving knife, pantliners, children's diapers, toilet paper and towel.

In addition to the hygiene necessities referred to in the Paragraph 3 of this Article, person seeking asylum can also be provided with dish washing liquid, disinfectants, sponges, mops, garbage bags and liquid dispenser for glass.

III ACCOMMODATION OF PERSON GRANTED WITH THE STATUS OF REFUGEE

Article 13

A person granted with the status of refugee (hereinafter: refugee), who is unable to provide accommodation for themselves, shall be provided with one in facilities that are designated for this purpose by the State.

Article 14

Pregnant refugee and single parent with child up to three years of age, physically and mentally ill person, elderly person, person who was subject to drug abuse rehabilitation, person addicted to alcohol abuse, children with behavioral disorders, shall be provided with accommodation in appropriate institutions of social and child care or in another suitable way.

Article 15

During accommodation of a refugee family, unity of the family will be ensured.

During accommodation of an unaccompanied minor, the best of interests of the minor shall be taken into account.

Article 16

Accommodation of person granted subsidiary protection or person granted temporary protection shall accordingly be subject to provisions of this Rulebook regulating accommodation of persons seeking asylum and persons granted with the refugee status.

IV FINAL PROVISION

Article 17

This Rulebook shall enter into force on the eighth day following its publication in the "Official Gazette of Montenegro".
