**A. 1<sup>st</sup> mandate (2001)**

1. After Armenia and Azerbaijan became member States of the Council of Europe on 25<sup>th</sup> January 2001, the Ministers' Deputies decided to look into cases of alleged political prisoners in both countries. In this context, they approved the Secretary General's proposal to instruct (at that time) three Independent Experts<sup>1</sup> to inquire into cases referred to them. On 18 July 2001, the Secretary General informed the Committee of Ministers that he had received the experts' report and, in the light of developments in Azerbaijan, decided to make the Experts' report public on 24 October 2001<sup>2</sup>. Political follow-up to the Independent Experts' report is now being undertaken by the Committee of Ministers and the Parliamentary Assembly.

**B. 2<sup>nd</sup> mandate (as from 2002)**

2. In April 2002, two of the three experts, Professor Stefan Trechsel and Professor Evert Alkema, accepted the Secretary General's proposal to resume their task as Independent Experts and to provide opinions on whether or not the remaining group of prisoners in Azerbaijan, out of the list of 716 initially submitted to them in 2001, may be regarded as political prisoners, on the basis of the objective criteria adopted in their first report. This new task is presently being carried out.

3. As the Independent Experts noted discrepancies between information provided by the Azerbaijan authorities and Azerbaijan NGOs as to the number of persons in prison, out of the list of 716, they liaised both with the country's authorities and the Azeri NGOs concerned, in order to ensure exactly how many cases they must still deal with.

4. In so doing, the Independent Experts decided to examine the Azeri language transcripts of all cases, out of the list of 716, except the following:

- cases of persons not detained (released, deceased, repetition of another name);
- cases they have already examined<sup>3</sup>; and
- cases with respect to which NGOs were not able to provide additional information indicating that the persons on the list were actually detained (in a situation in which the authorities indicated that the persons on the list were not detained).

5. In March 2003, the Independent Experts established a list of 212 cases they will examine (see Appendix I)<sup>4</sup>, as well as a list of 504 cases they will not examine (see Appendix II). The lists were then transmitted to the Secretary General on 2 April 2003.

6. The Independent Experts have established the following procedure with respect to the cases they are now examining:

7. The first set of Opinions, with respect to this second mandate, is likely to be issued in May 2003.

8. Finally, it should be noted that - since the work of the Independent Experts commenced back in the spring of 2001 - a number of prisoners, out of the list of '716', have been released simply because their terms of imprisonment had come to an end. Others, have been pardoned by Presidential Decree, further to the Independent Experts' report to the Secretary General in 2001, and subsequent to informal contacts undertaken between the Independent Experts and the Azerbaijan authorities.
