



LOCALIZATION OF CONFLICT INCIDENTS

<u>Note:</u> The following list is an overview of the incident data included in the ACLED dataset. More details are available in the actual dataset (date, location data, event type, involved actors, information sources, etc.). In the following list, the names of event locations are taken from ACLED, while the administrative region names are taken from GADM data which serves as the basis for the map above. Data on incidents in the Abyei area are not reflected in this update.

In Central Equatoria, 25 incidents killing 28 people were reported. The following locations were affected: Bari, Gobur, Juba, Lobonok, Luri, Mangalla, Morobo, Wonduruba.

In **Eastern Equatoria**, **3** incidents killing **9** people were reported. The following locations were affected: **Chukudum**, **Magwi**.

In Jungoli, 24 incidents killing 76 people were reported. The following locations were affected: Akobo, Ayod, Bor, Dhiak Kuei, Jalle, Padak/baidit, Panyagor, Pibor, Pochalla, Toch.

In Lakes, 3 incidents killing 25 people were reported. The following locations were affected: Cueibet, Paguere, River Yei.

In North Bahr-al-Ghazal, 10 incidents killing 15 people were reported. The following locations were affected: Akoc, Aweil, Gok-machar, Mayen, Nyamlell, Turalei.

In **Unity**, 10 incidents killing 18 people were reported. The following locations were affected: **Bentiu**, **Koch**, **Leer**, **Mayendit**, **Nyal**.

In **Upper Nile**, 22 incidents killing 110 people were reported. The following locations were affected: **Kadugli**, **Ketbek**, **Maban**, **Makak**, **Malakal**, **Nasir**, **Nasser**, **Panyang**, **Renk**, **River Sobat**, **Torpot**, **Wadakona**.

In Warap, 25 incidents killing 85 people were reported. The following locations were affected: Gogrial, Jur, Koch, Kuajok, Majok, Ngabagok, Thiet, Tonj, Wau.

In **West Bahr-al-Ghazal**, **8** incidents killing **12** people were reported. The following locations were affected: **Abu Shakka**, **Bisellia**, **Boro Medina**, **Bussera**, **Mapel**, **Raja**, **Safa**.

In West Equatoria, 28 incidents killing 86 people were reported. The following locations were affected: Birisi, Ezo, Gangura, Gariya, Ikpiro, Kediba, Khor Uze, Lanyi, Li Rangu, Lui, Mambe, Maridi, Meke, Mundri, Yambio.

METHODOLOGY

The data used in this report was collected by the Armed Conflict Location & Event Data Project (ACLED). ACLED collects data on reported conflict events in selected African and Asian countries, South Sudan being among them. ACLED researchers collect event data from a variety of sources and code them by date, location, agent, and event type. For further details on ACLED and for the full data, see www.acleddata.com und Raleigh; Linke; Hegre, and Karlsen, 2010.

Based on these data, the Austrian Centre for Country of Origin & Asylum Research and Documentation (ACCORD) compiles updates on conflict incidents.

Incidents comprise the following categories: battle, headquarters or base established, non-violent strategic activities, riots/protests, violence against civilians, non-violent transfer of territory, remote violence. For details on these categories, please see
