Responses of France to recommendations

1. France is deeply committed to the universal periodic review process. It is a unique process that allows all States to provide information on the measures taken to improve the human rights situation in their territory and to evaluate persistent challenges. France considers the universal periodic review as an essential tool for evaluating and updating public policy on respect for and the promotion of human rights.
2. France has carefully considered the 297 recommendations it received. All the ministries concerned participated in drafting the responses to the recommendations and the National Consultative Commission on Human Rights was consulted during the process.
3. This addendum is supplemented by an annex explaining the position taken by France in respect of each of the recommendations.
4. France **accepts 238**, or 80 per cent, of the recommendations made. These are either recommendations whose wording and intention it supports, or those it has already implemented.
5. France **partially accepts** the wording and intention of **34 recommendations** which it generally approves of but cannot fully implement, either because it does not agree with part of the recommendation, although it could implement the other part, or because of legal or constitutional obstacles that prevent the full implementation of the recommendation.
6. France **takes note of the 25 recommendations** that it is not in a position to implement for legal or constitutional reasons, whose content it does not support, or whose claims it rejects.
