















Number of persons convicted of trafficking in persons and related offences, by sex, 2014 – September 2017





Additional information

The Federal Public Service Justice of Belgium notes that in 2016, there is a significant increase in convictions for trafficking. This increase may be related to an actual increase in decisions, but it may also be the result of an increase in false positive trafficking cases due to the increased migration of refugees throughout Europe. However, authorities note that despite the impact on convictions due to increased migration, there is a parallel increase in trafficking which also has caused an increase in decisions.









Number of persons prosecuted for trafficking in persons, by sex, 2014 – September 2017










Number of cases of trafficking in persons reported to police, 2014 – September 2017**







Number of victims of trafficking detected, by age and sex, 2014 - September 2017












Number of persons convicted of trafficking in persons in the first instance, 2015-2017



Number of victims of trafficking in persons detected, by form of exploitation, $2014-September\ 2017$
















Number of victims of trafficking in persons and related offences detected, by form of exploitation, 2016 – 2017









Number of persons prosecuted for trafficking in persons, by sex, 2014 – 2015





















Number of victims of trafficking in persons detected, by age and sex, 2014 – 2017














Number of victims of trafficking in persons detected, by age and sex, 2014 – 2017







Number of victims of trafficking in persons detected, by age and sex, 2014 – 2016



























Number of victims of trafficking in persons detected, by form of exploitation, 2014-2016





Identified victims of trafficking, by type of trafficking, 2014 – July 2017









Number of persons brought into formal contact with the police and/or criminal justice system because they have been arrested for trafficking in persons, by sex, 2014-2016





Number of persons prosecuted for trafficking in persons, by sex, 2014 – 2016
















Number of persons convicted of trafficking in persons, by sex, 2014 – 2016


Citizenships of persons convicted of trafficking in persons, 2014 – 2016


Number of victims of trafficking in persons detected, by age and sex, 2014 - 2016





Number of cases of trafficking in persons recorded, 2014 – 2015





Number of persons prosecuted for trafficking in persons, by sex, 2014 – 2015





Number of persons convicted of trafficking in persons, by sex, 2014 – 2015





Number of victims of trafficking in persons detected, by age and sex, 2014 – 2015







Between April 2016 and March 2017, a total of 2,325 cases were reported. The majority of cases were located in England and Wales.





Number of victims of trafficking in persons detected, by age and sex, 2014 – 2016




