

#### **NATIONAL CLUSTER UPDATE**


The CCCM Cluster contributed to the South Sudan's inter-agency Humanitarian Project Cycle (HPC) process and the development of the CCCM Response Strategy for 2021. As part of this process, the CCCM Cluster finalized the identification of People in Need in 2021. It is expected that 1.3 million individuals in South Sudan will be in need of CCCM services in 2021. In addition , the Cluster provided inputs to the United Nations Office for the Coordination of Humanitarian Affairs (OCHA) for inter-sectoral severity analysis to prioritize the response in 2021.

The CCCM Cluster continued to coordinate COVID-19 related response and preparedness activities in PoCs, former PoCs, and IDP sites. CCCM cluster also provided support on PoC transition process at the state level through developing community engagement plans, PoC transition humanitarian plan etc.


#### 2021 Key HRP Figures

#### RESPONSE OVERVIEW

As per the humanitarian needs overview (HNO) 2021, the CCCM cluster has identified around 46 counties under level 4 and level 5 severity where displaced people need assistance from CCCM cluster. Cluster has identified a total of 1.3 million displaced people are in need of whom 900,000 have been targeted to be served by cluster partners in 2021. Cluster categorized IDPs in 3 categories based on their settlement status. 1.IDPs in PoC/ Former PoC Sites, 2.IDPs in collective sites and 3. IDPs in spontaneous/informal settlements or with host communities. Targeting approach is 100% PIN of first 2 categories and 60-70% PIN of third category.

In January over 250,000 IDPs were reached by 5 CCCM Cluster partners who responded in various IDP sites and displacement locations where they provided IDPs with CCCM services including coordination of service provision, site care and maintenance, safety audits, communication and community engagement, COVID-19 preventive awareness rasing, leadership training, and monitoring service provisions inside the IDP/PoC sites.

#### **UNITY**

#### PoC & IDP Sites

- IOM Camp management in Bentiu PoC site continued its active engagement with UNMISS and humanitarian partners to facilitate the development and roll out of the PoC Transition Work plan and the Community Engagement Strategy which includes key messages on the transition. This was done amidst persisting threats to humanitarian aid-workers whereby the youths in the PoC are against other South Sudanese who hail from other states from working in Unity State, PoC inclusive.
- In its efforts to strengthen self-management capacities and promote participation of IDP community in camp governance structures and decision making process, CCCM team inaugurated new elected PoC High Committee leaders in a ceremony that was presided over by camp management, United Mission in South Sudan (UNMISS) represented by Relief, Rehabilitation and Protection (RRP) as Camp Administration and attended by outgoing committee leaders and representatives from several community structures.

#### Covid-19 Update

• The number of Covid-19 cases saw an upward trend with 51 cases reported as of 31 January 2021, the majority of whom were health care workers. In response to the upsurge in cases Covid-19 Task-force was re-activated, contact tracing was initiated and sensitization on Covid-19, messaging and awareness raising was intensified utilizing different communication and information sharing platforms.

#### **CENTRAL EQUATORIA**

#### **PoC & IDP Sites**

- ACTED camp management facilitated 2 meetings with the Relief, Rehabilitation Commission (RRC) the South Sudan government incoming camp administration, RRP the UNMISS current camp administration, CCCM Cluster, and UNDSS during which the RRC were given an overview of Juba IDP camp and the community concerns regarding the intervention of the RRC:
- RRC and RRP to continue engaging in a smooth transition of camp administration roles and responsibilities, ACTED to continue to make RRC familiar with the overview and management of Juba IDP camps and RRC to provide feedback on the questions and concerns raised by the community.
- •As at the end of 2020, there has been a drastic reduction of service providers in Juba former PoCs. This reduction has affected service provision in the site. The worst hit sector is WASH and the IDPs have witnessed a reduction of the quantity of water being trucked to the site. Similarly, communal pit latrines are not being desludged. As such, most IDPs have opted to open defecation. With the coming of the rainy season, there is worry of a possible Cholera outbreak unless these gaps in WASH services are addressed.

#### Covid-19 Update

 $\bullet$  COVID-19 awareness by all sector partners is ongoing. ACTED have requested WHO to provide dead body management training in the IDPs camps but up-to now there has been no response.

#### **JONGLEI**

#### **IDP Sites**

- ACTED Camp Management in Bor IDP site held a meeting with UNICEF and discussed the WASH challenges which have existed since International Aid Service (IAS), a WASH service provider, pulled out due to lack of funding. The discussion focused on the desludging and construction of latrines and the need for continuing provision of clean drinking water in the camp.
- In Jonglei, Health Link South Sudan (HLSS) working in collaboration with RRC have conducted meetings with the community, partners and IDPs to identify gaps in service provision and to address the challenges by coordinating humanitarian services provision by partners.
- CCCM-HLSS is lobbying for partners to respond on WASH and to drill boreholes in all IDPs sites of Kondaai/Gakyuom, Malual Agor-Baar, Tara Agok and Pabial/Stadium in order for IDPs to have access to clean water and also to have hygienic environment.

#### Covid-19 Update

 $\,^{\bullet}$  As part of the CWC, using loud speakers ACTED continues broad casting COVID-19 and health care awareness messaging as well as other key humanitarians 'updates inside the IDP site.

#### **UPPER NILE**

#### PoC & IDP Sites

- To improve on Communication with Community (CwC) and information dissemination, camp management supported POC community coordination committee (PCCC) and youth office with stationery (printing papers and pens) and two megaphones to be used for messaging in the PoC. The Youth office was also supported with 5 Jerry cans and 25 liters' paint for the painting of the youth center.
- Within the reporting period camp management facilitated the burial of 16 dead bodies (7 female/9 male) in Malakal PoC by providing grave digging tools and transportation of the bodies from morgue to graveyard. Each family of the deceased was also supported with 5 Kgs of sugar and coffee for the funeral service.
- Camp management conducted two-day training for a group of 25 women in Malakal town centered on coordination mechanisms, community participation and lifesaving COVID-19 messaging.

#### Covid-19 Update

 Camp management conducted 7 COVID-19 awareness sessions both in Malakal town (Nile palace water point) and Malakal POC (at block level) attended by 575 individuals (428 females/147 males) during which 100facemasks were distributed.

#### **WESTERN BAHR EL GHAZAL**

#### **PoC & IDP Sites**

- In Naivasha IDP site IOM camp management continued to ensure coordinated, inclusive and timely service provision after the transition of the PoC site to formal IDP site. Working towards the local capacity building component of the transition workplan, IOM conducted 3-days camp administration training for government counterparts including RRC, SSNPS and municipal Council in addition to local NGOs and several community representatives
- Camp Management handed over an office space, including office supplies and stationery, within the Naivasha IDP site to RRC which will ensure their static presence in the site and attend to IDPs complaints and address their concerns.
- In Hai Masna Collective Center, camp management facilitated 2 Town Hall meetings to introduce the new leadership of Hai Masna to the IDP community.
- Camp management continued to advocate for the inclusion of a new caseload of 721 individuals in food assistance programmes through the Protection Cluster and in relevant former.

#### Covid-19 Update

 COVID-19 messaging, awareness raising and rumour tracking continues in Naivasha IDP site and Hai Masna Collective Center through a network of community mobilizers and outreach workers trained on delivering messages and collecting community perceptions and concerns.

### **Assessments and Mobile Response**

#### **ASSESSMENTS AND MOBILE RESPONSE**

IOM CCCM along with Shelter/NFI, and Protection teams conducted an inter-sectoral assessment mission to Bazia area to identify IDPs in locations that have never been reached by humanitarians to be targeted for mobile response supported by the SSHF fund. Following the mission, the team convened for a post-mission debriefing in which findings from each sector were presented and recommendations were shared for the targeted locations. Based on population dynamics, availability of partners and severity of needs Gedi and Gumaba areas of Bazia Payam were recommended for subsequent response missions.

CCCM cluster partners also carried out scoping missions in various locations where there are potential needs for a mobile response. ACTED carried out a scoping mission to Mingkaman in Lakes and Lobne Payam in Eastern Equatoria. In Malakal, DRC supported 3-day assessment lead by shelter /NFIs partners in the flood affected areas of Ogod county.


#### **FLOOD RESPONSE**

CCCM cluster provided updates to OCHA on flood response for the people displaced by flooding who relocated and are living in Mangalla IDP site. It is unlikely that the IDPs will return to their area of origin as water level in the Nile are still high due to rain in Uganda. Currently Camp Management activities in Mangalla IDP site are being carried out by a national NGO who have been trained by cluster partners on how to implement CCCM activities effectively and in line with CCCM standards.

## NEW DISPLACEMENTS SITES & OTHER UPDATES

- In January 2021, IOM DTM observed new displacement in \ Pagol, Awul & Manalor in Tonj North and Pathoun East in Gogrial East.
- The community in Aburoc are questioning the World Vision mobile health service provision as they think such approach does not address the IDPs emergency health needs. They therefore, requested camp management and the government of South Sudan to lobby for a static presence of health services in IDP site.
- Following a request from the government for an assessment to flood affected areas in Fashoda and Manyo counties, camp management participated in the multi-sector assessment that was conducted from 21-22 January 2021. The assessment, coordinated and facilitated by UNOCHA representative in Fashoda and the government of former Fashoda State, visited Lul, Kodok, Dethwok, Abenyai, Manyo and Athiduwei payams.
