Land violations committed in February 2021

| 2 February | 2200 | In occupied Palestinian territory, opposite the town of Rumaysh, an Israeli enemy Merkava tank moved from the enemy Matat barracks position to near the enemy Rumaysh Gate position and conducted a patrol. It moved back and forth between the two positions while pointing its cannon in the direction of Lebanese territory throughout. The left in the direction of the Matat barracks at 2355 hours. |
| 3 February | - | In Lebanese territory, in the town of Bustan, the DanChurchAid organization detonated three landmines left behind by the Israeli enemy. |
| | 0630 | In occupied Palestinian territory, opposite the town of Udaysah, near point TP36, five Israeli enemy civilian vehicles approached. Some 20 individuals in civilian clothing disembarked, scouted the area and took photographs of the Lebanese side. They left in the direction of occupied territory at 0800 hours. |
| | 1045 | In occupied Palestinian territory, at the Israeli enemy position east of Mays al-Jabal, Israeli enemy personnel pointed the cannon of a Merkava tank at Lebanese territory. The tank left in the direction of occupied territory at 1320 hours. |
| | 1305 | In Lebanese territory, near UNIFIL post 31-1 in Labbunah, the Chinese UNIFIL contingent detonated 13 landmines left behind by the Israeli enemy. |
| | 1500 | Israeli enemy warplanes carried out mock strikes over the Arqub area and the occupied Shab'a Farms. |
| | 1815 | In the occupied Shab'a Farms, the Israeli enemy fired two flares over the enemy Ruwaysat al-Alam position, while combing the area with light- and medium-weapon fire and deploying tanks in the vicinity of the position. |

| | 1130 | In occupied Palestinian territory next to the Israeli enemy Tall al-Rahib site, opposite point BP13 and the town of Ayta al-Sha'b, a civilian car, a civilian jeep, two Defender vehicles, a Chevrolet vehicle, two Rangler vehicles and a civilian pickup approached. Two personnel in military uniform with full gear and two civilians carrying cameras disembarked from the car and the jeep. The two civilians conducted an interview with the two soldiers, while filming in the direction of Lebanese territory. One of the civilians said something in Arabic to a Lebanese Army patrol. The interview ended at 1300 hours, and all those involved left in the direction of occupied territory. |

| 5 February | _ | In Lebanese territory, in the town of Bustan, the DanChurchAid organization detonated two landmines left behind by the Israeli enemy. |
| | 1240 | In occupied Palestinian territory, opposite the town of Mays al-Jabal in the Kurum al-Sharaqi area and points B64 and B65, an Israeli enemy foot patrol consisting of 20 personnel in military uniform and a dog approached. They crossed the technical fence at the gate opposite point B64 without breaching the Blue Line. They inspected the barbed wire between points B64 and B64 (1) and pointed their weapons at Lebanese army personnel several times. The patrol left in the direction of occupied territory at 1340 hours. At 1400 hours, the same patrol moved to a location opposite points BP31 (1) and BP31 (2). Five soldiers deployed behind the earthen berm that runs alongside the technical fence while pointing their weapons at Lebanese army personnel. Some 15 soldiers and a dog also crossed the technical fence at the gate opposite BP31 (1) and searched the spot between point BP31 (1) and B66. They pointed their weapons at Lebanese Army personnel several times. The patrol left in the direction of occupied territory at 1435 hours. During that time, a Merkava tank pointed its cannon at Lebanese territory from inside the enemy Dahr al-Asi position. |
| | 1305 | In Lebanese territory, near UNIFIL post 31-1 in Labbunah, the Chinese UNIFIL contingent detonated 18 landmines left behind by the Israeli enemy. |
| | 1355 | In occupied Palestinian territory, opposite the town of Hula, at the Israeli enemy Shaykh Abbad position, a group of five individuals in military uniform with maps approached, scouted the area and photographed the Lebanese side. They left in the direction of occupied territory at 1415 hours. |
