Executive Summary

1.1 Security Assessment

To begin, the survey looked to assess respondents' perceptions of security in their neighborhoods and governorates. In general, the respondents indicated that they felt generally safe in their neighborhoods and governorates, as 19.3% and 42.7% stated that they felt very safe and rather safe in their neighborhoods, respectively, compared to 18.7% and 37.3% at the governorate level. The respondents indicated that they felt generally more unsafe at the governorate level than at the neighborhood level. In fact, around 35.3% stated that they felt rather unsafe and not safe at all in their neighborhoods while 41.3% stated the same for the governorate level. This is generally an indication that Iraqis feel safer in their local areas than they are beyond the parameters of their towns.

Looking at the results in terms of gender, males indicated that they felt safer in both of their neighborhoods and their governorates. In fact, they felt 11.7% and 13.4% points safer in these two locations, respectively. Further, females were, on average, about 10.4% more likely to feel unsafe in these locations.

As for the governorate level, Baghdad was the governorate where respondents felt most safe in their neighborhoods and in their governorate, followed by Basra and Mosul at both levels. The difference was rather stark, as Baghdad felt about 16.3 percentage points safer than the two other governorates. Mosul felt near 20 percentage points more unsafe than Baghdad at the local level and about 16 percentage points at the provincial level. It is also worth noting that the perceptions of safety seemed to increase among older respondents compared to their younger counterparts. Given the small sample, the difference in the perception of safety between Basra and Mosul's respondents was very minimal. In both governorates, 50.7% of the respondents felt very or rather unsafe in their governorates, compared to 45% at the neighborhood level.

In terms of ethnic and religious levels, Kurds were more likely to indicate that they felt safe compared to Arabs at the local and provincial levels. Christians felt most safe in their neighborhoods, followed by Sunni Muslims and lastly Shia Muslims, albeit Shia Muslims felt safer, to an extent while Sunni Muslims were more likely to indicate "feeling very safe." Conversely, when it comes to the governorate level, Christians were the religious group less likely to indicate feeling safe in their governorates, as Sunni Muslims ranked highest followed by Shia Muslims.

Looking at street crime and violence, 4.3% of the respondents stated that they have often experienced or witnessed street crime, followed by 28% who have occasionally experienced such events. On the other hand, 29.7% have seldom experienced similar incidents, as 33.7% have never experienced or witnessed street crime. Further analysis shows that males were more likely to often or occasionally experience or witness street crime than females, with about 2.7 percentage points difference. Moreover, younger respondents, aged 16-18 were also more likely to experience or witness street crime, as Baghdad was the least likely governorate. Kurds indicated that they have often or occasionally experienced or witnessed street crime, as Baghdad was the least likely governorate. Kurds indicated that they have often or occasionally experienced or witnessed street crime, more so than their Arab peers. In terms of religious groups, Christians were the single group most likely to experience or witness street crime, followed by Shia Muslims, and finally Sunni Muslims.



As for violence, such as assault, fights, and brawls, 8.7% of the respondents stated they have often experienced or witnessed that, followed by 31% for occasionally and 11% seldom experienced that. 46% stated that they have never experienced or witnessed violence. Females were slightly (0.4%) more likely to experience or witness violence, as Basra was the governorate where such events are more likely to take place, followed by Mosul, and finally Baghdad. Arabs were about 7.1 percentage points more likely to experience or witness violence than Kurds. Similar to street crime, Christians were also the religious group most likely to experience or witness violence, followed, this time, by Sunni Muslims, and Shia Muslims.

1.2 Economic Conditions

The next section of this survey delved into the respondents' economic conditions. The survey finds that 33.7% work continuously, coupled with 37.7% who occasionally work, as 25.3% are unemployed or do not have any work. Unsurprisingly, male respondents stated that they were continuously and occasionally working more so than their female counterparts. In fact, an average of 14.3% more males were working (whether continuously or occasionally) than females. In terms of the three governorates, Baghdad appeared as the place where more respondents were working, followed by Mosul. Further, more Arabs were continuously working while almost twice as many Kurds were occasionally working.

Of those who work, 26.4% and 29.8% work full-time or part-time, respectively. Further, 9.8% work at several part-time jobs, 14.9% are daily-wage workers, and 11.9% work seasonally. The plurality of the respondents, 39.7%, earn below 518,000 Iraqi Dinars per month (~\$354.7) If we were to calculate the average wage per month, we find that the respondents earn an average of \$355-410 per month. Moreover, 47.8% of Basra's respondents earn below IQD 518,000 per month, while about 19% of Mosul's respondents earn IQD 900,000 or more.

Nevertheless, the survey finds that the respondents were, on average, able to provide for themselves and their families. In fact, 38.7% of the respondents were fully able to provide sufficient food stuff for themselves and their families, followed by 23.7% who could barely manage to do so and 22.7% who hardly manage that, as 11% stated they were not able to provide that. More male respondents stated that they were able to provide sufficient food items for themselves/ their families, with a 10.4 percentage points difference. Such respondents were more likely to be from Basra or Mosul. However, much more respondents from Mosul were not at all able to provide such items.

Similarly, when asked about their ability to provide basic consumer goods, such as clothing, shoes, and mobile phones, 25.7% stated their full ability while 28% and 27% could barely and hardly manage to provide such items for themselves or their families, respectively, as 14.7% indicated they were not able to attend to that. About 20.7% of female respondents were not at all able to provide such items, compared to 9.1% of males, as 6.5% more males were able to provide for themselves/ their families. In terms of governorates, a staggering 32% of Basra's respondents were not at all able to provide for themselves or their families, compared to 9.3% in Baghdad and 8% for those from Mosul.

Following that, the survey gauged respondents' perceptions in relation to school education for their children. Of those who have school-age children, 64.8% indicated that their children are able to attend school while 23.5% indicated that their children are not able to attend school. Of those who affirmed their children's ability to go to school, near 70% are enrolled in public/ governmental schools and 16% attend private schools. The survey also found that the respondents spend just



under IQD 700,000 (~\$480). For reference, this higher than what the average respondent earns per month, signifying the burden school education poses on their monthly spending. Respondents from Baghdad spend the most on their children's school education, followed by those from Basra, and finally those from Mosul, of whom more respondents spend under IQD 700,000 per child per month.

Given the age of the respondents, the majority who have children stated that their children do not contribute to their household income while a total of 8.3% stated that their children contribute to some level to their household income.

The survey also asked the respondents aged 18-25 whether they have access to further training or higher education. The results show that only 31.5% have access to further training or higher education compared to 60.2% who do not have such access. When analyzing these results in terms of gender, the survey show that 11.8% more males had access to further training/higher education, as 25% of females stated they had such access, compared to 36.8% among males. The analysis also reveals that the majority of those who have access reside in Baghdad (42.4%), followed by 23.1% in Mosul and 12.5% in Basra. Shia Muslim were the group with the least access, as income also played a role in facilitating such access, with those earning more than IQD 700,000 were almost twice as more likely to have access to further training/ higher education.

1.3 Health

The next section of the survey is concerned with health, whereby the respondents were asked about their access to clean drinking water, hygiene products, and medical facilities and products. With that, the survey shows that near 60% always have access to clean drinking water, followed by 27% who sometimes have access and 10% who seldom have access. In terms of the three governorates, about 92% of Baghdad's respondents stated that they always or sometimes have access to clean drinking water, followed by 88% among Basra's respondents, and 75% among Mosul's. Kurds and Shia Muslims were the two ethnic and religious groups with better access to clean drinking water, as monthly income also played a major determining role in that regard.

Further, 36% of the respondents stated they always have all necessary hygiene products such as soap, shampoo, toothpaste, lotion, sanitizer, and feminine hygiene products. Looking at these results in relation to gender, the survey illustrates that 33.8% of female respondents could hardly have the necessary hygiene products or did not have them at all, compared to 23.3% among males. Respondents from Basra were least likely to have these products, as those from Baghdad appeared to be better equipped to access these items. It is also worth noting that younger respondents were least likely to have all these necessary hygiene products, entailing that increasing awareness is needed to ensure their health.

As for access for medical facilities and products, the results show that 44.3% of the respondents always have access to vaccinations, 55.3% always have access to COVID-19 vaccinations, 33.3% for doctors/ general practitioner, 32.3% for dentists, 29% for medical specialists such as gynecologists and pediatrician, and 30% for hospitals for treatment or surgery. The rest of the respondents illustrated a mix between having limited access, severely limited access, and no access at all. When analyzing the data further to produce mean scores (on a scale of 1 to 4, where 1 is lowest and 4 is highest), the results show reveal an average score of 3, which translates into "having limited access." The two lowest were 2.7/4 for each of "dentist" and "hospital for treatment/ surgery", which also translates into the higher end of "having severely limited access." In terms of the COVID-19 vaccines, respondents from Baghdad had the least access, followed by those from



Mosul. Kurds had much more access compared to Arabs, and Sunni Muslims also had the least access to the COVID-19 vaccines, as more than two-thirds of Shia Muslims stated that they have full access.

1.4 Housing

The fifth section of the survey focused on the respondents' housing and living situations. The results show that 52% of the respondents live with their parents or with their in-laws while 43% live in a dwelling of their own. Additionally, 63% live in houses, 28.7% live in apartments, and 2% in a shack. About 52.3% own their apartments or houses while 37.7% rent their dwellings. The survey also shows that 24% of the respondents pay less than IQD 250,000 (\$171.2) for their dwellings per month, followed by 24.7% who pay between IQD 250,001 and 500,000 (\$171.2 - \$342.35). On average, the respondents pay just a little under IQD 250,00 for their dwelling, per month. Coupled with what they pay for their children's school education, the respondents could be generally left in very tough financial conditions.

Looking at the general amenities of their dwellings, over 73% of the respondents had roofing, windows, doors, and televisions in their homes. Additionally, 65.3% have running water, 61.3% have flush toilet, and 60.3% have baths or showers. The survey results also show that 54.7% have stoves, 50.7% have internet connection, 45.7% have refrigerators, and only 28% have heating.

Unlike access to clean drinking water, access to electricity within the respondents' homes was somewhat infrequent. In fact, 30% and 30.7% stated that they always or sometimes have available electricity in their homes, respectively, while 34% mostly have available power and 5.3% never have available electricity in their dwellings. 73.3% of Mosul and Basra's respondents stated that they always or mostly have electricity available, compared to 54.7% among respondents from Baghdad. Nevertheless, 10.7% of Mosul's respondents indicated that they never have available electricity, compared to 4% among those from Baghdad and 2.7% for those from Basra.

Moreover, and when looking at the size of the dwellings, the results show that 1.7% of the respondents live at homes that are between $20 - 40 \text{ m}^2$, 5% live at homes that are $40-60 \text{ m}^2$, 17% at $60-80 \text{ m}^2$ homes, 26% live in homes that are $80-100^2$, as 24% live in homes that are $100 - 120 \text{ m}^2$ and 26% in homes larger than 120 m². Further analysis show that the average size of the dwelling is in the lower end between $80 - 100 \text{ m}^2$. Additionally, near 60% of the respondents live in homes with 5 or more individuals, including themselves. The average number of individuals living with the respondents was approximately 5 individuals, which entails that each individual has $16 - 20 \text{ m}^2$ to themselves.

When asked about the demographic composition of residents in their neighborhoods, the survey shows that 22.3% live in neighborhoods where residents are mostly of the same background while 40.3% live in neighborhoods with some residents with diverse backgrounds, and 35.7% with residents who are mostly of diverse backgrounds. Mosul was the governorate with more diverse backgrounds, followed by Baghdad. Kurds also lived in areas that are more diverse, while those with lower income were more likely to be residents of areas of diverse backgrounds.

1.5 General Satisfaction

Finally, the survey closed with a question inquiring about the respondents' general satisfaction with their lives. The results show that only 8% were very satisfied, 32.3% were rather satisfied, 36% were rather not satisfied, and 23.3% were not at all satisfied. Further analysis show that the



general satisfaction level of the respondents was 2.3 on a scale of 1 to 4, where 1 is lowest and 4 is highest. This mean score translates into "rather not satisfied."

Looking at the results in terms of gender, the results show that males were slightly more satisfied with their lives than female respondents. Further, 42.7% of Mosul's respondents stated that they were very or rather satisfied, compared to 40% among those from Baghdad and 38.6% for those from Basra. Interestingly, only 1.3% of Basra's respondents stated that they were very satisfied. Younger respondents were least likely to be satisfied, as 31.3% of those aged 16-18 were not satisfied at all, while about 46.1% of those aged 26-35 were very or rather satisfied. About 57.5% of Kurds were very or rather satisfied compared to 35.2% among Arab respondents. Additionally, 64.3% of Arab respondents were either rather not satisfied or not satisfied at all. Moreover, 64.1% of Sunni Muslims were either not satisfied at all or rather not satisfied, compared to 59.6% among Christians and 51.5% among Shia Muslims.

2. Detailed Methodology and Workplan

Based on a questionnaire provided by the Country of Origin Information Unit of the Austrian Federal Office for Immigration and Asylum, IRFAD's analysts ensured the full adaptation of the questionnaire to the local context, translated the questionnaire, and programmed the survey onto a CAPI program, as the interviews were conducted using electronic tablets.

IRFAD recruited, hired, and trained the field research team, with 2-3 researchers per governorate, along with a field team lead. IRFAD trained the team on this specific research project, with a description of the project in hand, an overview of the questions, descriptions of each question, and training on the wording/terminology. The training was concluded with mock interviews.

The interviews were conducted face-to-face, in the home of the respondent, using CAPI. The enumerators acquired an informed consent prior to the start of each interview after explaining the nature of the study.

The field team lead monitored the data collection and ensured the implementation of the quality assurance measures, and he was working closely with IRFAD's analysts to review the data on daily basis. The two individuals communicated with the enumerators constantly to provide them with their assignments for each day, including the numbers of interviews they have to complete, the demographic segments they have to achieve, and any specific instructions related to skipping patterns to ensure the achievement of a representative sample.

At the end of each day, each enumerator synchronized their tablets directly to the server to upload their completed questionnaires. The analyst reviewed each survey to ensure its completion, quality, and syntax.

Once the data was reviewed, quality assured, and translated, the analysts began the analysis phase, utilizing SPSS to produce frequency tables and cross-tabulations to cross-examine each question in terms of governorates, gender, age, ethnic groups, religious groups, and income groups. The analyst prepared the data for the report and analyzed the findings for each question and conduct cross-tabulations to provide demographic-based insights for each question. This report includes data visualization accompanied by deep analysis for each question, as illustrated in the **Executive Summary** section. The results are all in percentages. The margin of error is calculated around $\pm 5\%$ with a confidence rate of 95% at the level of the three governorates combines. As for each of the governorates separately, the confidence rate was 95% with a margin of error of approximately $\pm 6-8\%$. This is due to the sample size of 300 (150 for Baghdad out of approximately 3.12 million



individuals aged 16-35; 75 for Mosul out of approximately 437,580 individuals; and 75 for Basra out of approximately 713,640 individuals aged 16-35). It is worth noting that a nationally representative sample generally has a $\pm 3\%$ margin of error and for a country like Iraq, a national sample size should generally be between 2,000 and 3,000 respondents (near 500 of whom from Baghdad).

3. Sample

To start the survey, IRFAD's analysts drew a nationally representative sample of respondents aged 16-35, relying on IRFAD's past field research experience and knowledge of the three selected governorates. The sample is generally representative of the population and encompasses up to 100% of non-institutionalized respondents.

In designing the sample, IRFAD's analysts paid close attention to representation of gender, age groups, ethnic and religious groups, and minorities. IRFAD designed a sample that is stratified by urban status. Interviews were allocated to each stratum based on probability. After that, the district was the next component, which was randomly selected, followed by the sub-district, which was the primary sampling unit, to essentially divide each governorate into a series of high income/ high education sub-districts; medium income/ medium education sub-districts, and lower income/ lower education sub-districts.

Then IRFAD's field research team lead randomly selected the blocks, followed by the streets, both using the same methodology (probability). He randomly selected a starting point and guided the researchers. Each unit (household) on the street is counted as one to produce a final tally of eligible units, which he used to determine the skipping pattern. With that, the final achieved sample was as indicated in the table below:
