4,230 individuals were manually registered and 75,420 individuals were biometrically registered or updated in October 2021

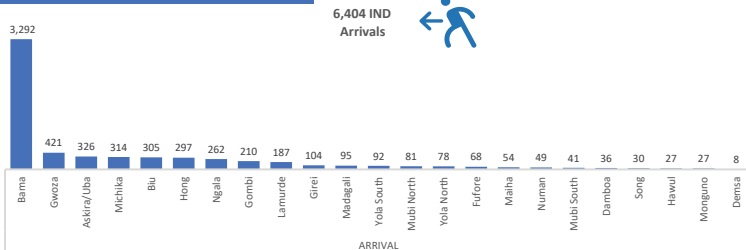
Month overview

The reporting month of October 2021 experienced a decrease in movement 7,787 Individuals (IND) as compared to September 12,336 IND resulting from increased security situation and improved poor living condition in the Northeast Nigeria. The sector recorded arrivals 6,404 IND and Departures 1,383 IND of the population across BAY State in October 2021. The highest arrival was into Bama LGA with 3,292 IND and Gwoza LGA recorded the second highest number of arrivals with 421 IND.

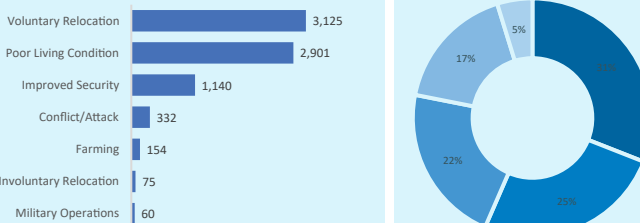
The onset of the harmattan has drawn more attention towards overcrowding in camps and camp-like settings which pose potential threat of fire outbreaks in camps, in addition, it has increased the risks of disease outbreaks and the humanitarian community continues to advocate for the decongestion of IDP camps. Early preparation and plans for a better curbing of the fire outbreaks during this harmattan season is a priority to the sector and its partners as its challenges and dangers brought about by the fire outbreaks

Over-crowding and congestion remain a serious concern, with majority of camps currently hosting populations beyond initial planned capacity. There is a need for a more sustainable solution for IDPs and returnees, and community training on building techniques and livelihood opportunities to promote self-reliance and resilience, while ensuring the availability of land in their area of choice and advocating for House, Land and Property (HLP) rights.

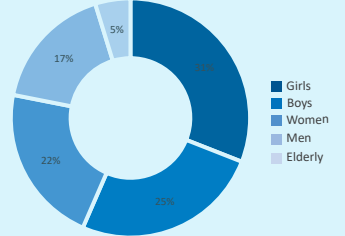
Summary of arrivals (October 2021)

Shelter/NFI gap and reach (October 2021)

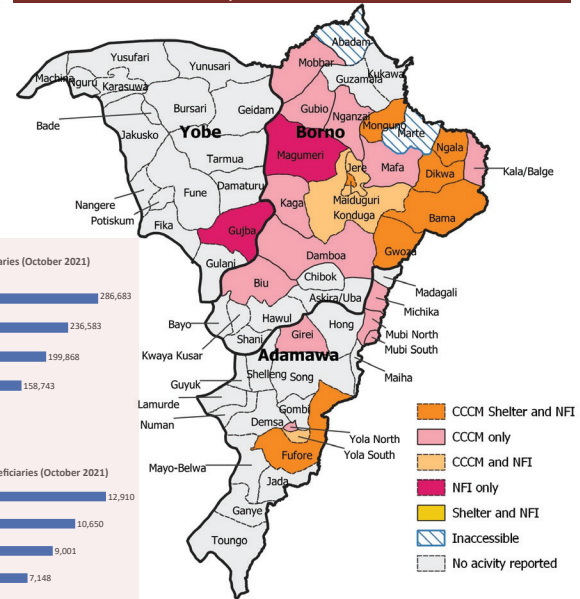


Challenges

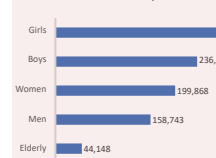
Funding and congestion in Borno state and limited presence of cross-sectoral humanitarian services in Adamawa continues to pose challenges for CCCM actors. Complaints ranging from health, wash, education, shelter, and livelihood have been recorded to be the most received from the affected population. In addition, delayed response by other sectors to advocacies raised by CCCM partners has also greatly impacted community engagement and participation.

In Borno, inadequate land to construct shelters for the relocation of IDPs from the reception centres, flood prone locations and congested camps continues to pose protection risks in camps. Shelter and NFI needs continue to be a priority across Adamawa state, to address the existing gap the sector will strengthen coordination with active Shelter and NFI partners, government, and other humanitarian sectors to ensure vulnerable displaced persons to receive physical protection and dignity through provision of shelter, NFI and other basic humanitarian assistance.

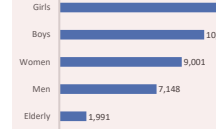

CCCM beneficiaries (October 2021)



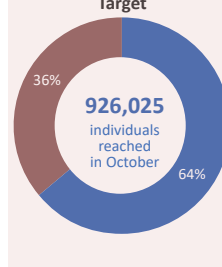
Shelter & NFI beneficiaries (October 2021)

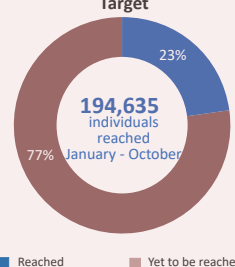
Camp Coordination and Camp Management

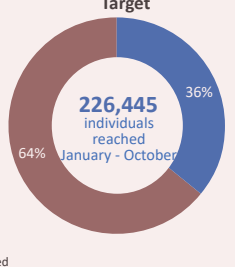

Response



In the reporting month, a series of site improvement activities such as clearing of drainages, environmental waste management, rehabilitation of fire stations, rapid assessment of camp facilities and structures to ascertain the gaps and further advocate for repairs and interventions was carried out in camps and camp-like settings benefitting from CCCM interventions across Borno and Adamawa state. As part of the AAP exercise in camps and camp-like settings, CCCM partners carried out a series of campaigns and hygiene promotions in camps that encouraged the participation of the community at large with participants over 25,000 in Borno and 15,000 in Adamawa camp residents being reached. As sensitization on fire outbreak is ongoing, women, girls and boys are carried along by distributing flyers, various FGD groups and use rallies method with boys within the camp to spread message wider and encourage more participation by the displaced population.

Collectively, the sector and its partners continued to provide lifesaving and life sustaining assistance in flexible and targeted approach while adhering to appropriate standards of humanitarian support. Within the reporting month of October 2021, 6,132 HH benefitted from NFI support, 871 HH were reached with emergency shelter solution while 737 HH benefitted from transitional shelter solution in Borno state. In Adamawa state, 300 HH benefitted from emergency shelter kit and NFI kit distribution. Construction of 20 partitioned communal shelter solution is ongoing to cater for 500 HH in Bama to provide shelter for vulnerable displaced families living in the open.
