KEY DEVELOPMENTS

USAID Administrator Power Announces \$387 Million in Additional Humanitarian Assistance for Ukraine

During a May 5 international donor conference in Warsaw, Poland, USAID Administrator Samantha Power announced nearly \$387 million in additional USAID/BHA humanitarian assistance for communities in Ukraine affected by the February 24 Government of the Russian Federation (GoRF) invasion of the country. The announcement brings the total FY 2022 U.S. Government (USG) humanitarian assistance supporting people in Ukraine and those who have fled to neighboring countries to more than \$688 million through UN agencies and international non-governmental organization (INGO) partners, including nearly \$477 million and \$212 million from USAID/BHA and State/PRM, respectively.

This additional funding will support USG partners to distribute life-saving emergency food assistance across Ukraine, including to people residing in hard-to-reach areas, as well as multipurpose cash assistance (MPCA) to help people meet their basic needs in areas with functioning markets. The assistance will enable partners to provide safe drinking water, increase sanitation and hygiene support, and meet critical nutrition and health needs among conflict-affected populations. USG funding will also support scaled up protection services and bolster logistics capabilities among relief actors to move vital humanitarian commodities to affected areas.

Invasion Continues to Exacerbate Humanitarian Needs; DART Staff Meet With Relief Actors in Lviv City

The ongoing GoRF invasion of Ukraine continues to generate and exacerbate humanitarian needs, result in civilians casualties, and prompt widespread displacement, particuarly in areas of eastern and southern Ukraine, where GoRF forces have escalated attacks since mid-April, the UN reports. The invasion had resulted in at least 3,280 civilian deaths, including 231 children, and injury to more than 3,450 people as of May 4, although actual figures are likely significantly higher as ongoing hostilities disrupt reporting, according to the Office of the UN High Commissioner for Human Rights (OHCHR). In Donetsk Oblast, hostilities—including suspected GoRF shelling of an industrial plant where civilians were sheltering in Avdiivka city—resulted in at least 21 civilian deaths and injury to 27 people on May 3, representing the highest number of daily civilian casualties in the oblast since the April 8 GoRF attack on a railway station in Kramatorsk city, international media report. The same day, GoRF forces struck six electrical substations along railways in central and western Ukraine, including in Lviv Oblast's Lviv city, where the attacks temporarily restricted access to power and affected municipal water pumping systems.

On May 2, USG personnel—including USAID Disaster Assistance Response Team (DART) members—travelled to Lviv city to discuss humanitarian conditions, response activities, and challenges with Government of Ukraine

(GoU) officials and UN and NGO staff, including from USG-funded organizations. The visit represented the first DART trip into Ukraine to coordinate the USG's humanitarian response to the complex emergency since the February 24 invasion. The DART continues to closely monitor humanitarian and security conditions in Ukraine and coordinate the scale-up of assistance to affected communities.

ICRC, UN Evacuate Hundreds of Civilians From Mariupol City and Steel Plant, Areas of Zaporizhzhya; USG Partners Provide Immediate Assistance

The International Committee of the Red Cross (ICRC) and UN evacuated approximately 100 civilians from the Azovstal steel plant in Donetsk's Mariupol city on May I via a safe corridor the organizations established in coordination with the GoRF and GoU, the UN reports. Prior to the evacuation, hundreds of civilians had been taking cover from GoRF attacks in underground facilities at the plant for approximately two months. Additionally, 58 civilians joined the evacuation convoy in Donetsk's Manhush town, near Mariupol. Relief actors subsequently escorted nearly 130 of the evacuees to Zaporizhzhya *Oblast's* Zaporizhzhya city, northwest of Mariupol, where they arrived on May 3, while other evacuated civilians relocated to different areas in the region. Following the convoy's arrival in Zaporizhzhya, relief actors—including USG partners—immediately provided vital humanitarian assistance to the evacuated civilians. USAID/BHA partner the UN World Food Program (WFP) distributed emergency food assistance, while USG partner the UN Children's Fund (UNICEF) provided nutrition assistance, safe drinking water, and critical psychosocial support services, to evacuees.

Furthermore, on May 5, the ICRC and UN evacuated more than 300 additional people from Mariupol city, Manhush, and Zaporizhzhya's Berdyansk, Tokmak, and Vasylivka cities to Zaporizhzhya city in coordination with the GoRF and GoU, according to the UN. However, while the ICRC and UN continue negotiations to evacuate additional individuals sheltering beneath the steel plant, resumed GoRF attacks on the facility since May 2 had precluded further evacuations from the plant as of May 5, according to international media. Local officials report that a contingent of GoU forces and more than 200 civilians, including at least 30 children, remained at the plant with limited supplies of food and water as of May 3.

Relief Actors Reach 4.1 Million People With Assistance in Ukraine, as Access Constraints Hamper Delivery to Some Besieged or Occupied Cities

Despite ongoing hostilities and persistent humanitarian access constraints, relief actors—including USG partners—reached nearly 4.1 million people across Ukraine with life-saving humanitarian assistance between February 24 and April 28, according to the UN. This figure represents nearly half of the 8.7 million people identified to receive immediate assistance through the April 24 UN Flash Appeal for Ukraine. Assistance provided includes food security and livelihoods support reaching more than 3.9 million people, health care interventions for nearly 957,000 individuals, services mitigating and responding to protection risks reaching more than 305,000 people, and other interventions.

Meanwhile, the WFP-led Logistics Cluster—the coordinating body for humanitarian logistics activities, comprising UN agencies, NGOs, and other stakeholders—continues to facilitate the delivery of life-saving assistance across Ukraine, including to hard-to-reach areas, with USAID/BHA and other donor support. On April 26, Logistics Cluster partners transported 78 metric tons (MT) of humanitarian commodities from Dnipropetrovsk *Oblast's* Dnipro city to Mykolayiv *Oblast's* Mykolayiv city for onward distribution to conflict-affected communities, and the cluster had transported approximately 8,200 MT of assistance for distribution countrywide as of April 27. However, UN agencies and INGOs had been largely unable to reach populations in the besieged or GoRF-occupied cities of Mariupol and Kherson, Kherson *Oblast*, as of April 28, according to the UN, and humanitarian agencies continue to negotiate to allow the safe passage of relief commodities and staff into besieged and GoRF-occupied areas.

U.S. GOVERNMENT RESPONSE

LOGISTICS AND RELIEF COMMODITIES

USAID/BHA partners are working to transport relief commodities to Ukraine from neighboring countries and provide these items to conflict-affected individuals as security and humanitarian access conditions permit. USAID/BHA recently delivered hygiene supplies sufficient to support 47,500 people for one month to the International Organization for Migration (IOM) in Lviv *Oblast* for distribution and approximately 47,000 high thermal blankets to the UN agency in Slovakia for onward dispatch to Ukraine. Overall, USAID/BHA had provided IOM with approximately 87,000 blankets; 20,000 High Energy Biscuits (HEBs); 18,500 kitchen sets; and 4,800 10-liter water containers, as well as water tanks and treatment units, to meet humanitarian needs within Ukraine as of April 27.

Moreover, USAID/BHA is supporting WFP to lead the Logistics and Emergency Telecommunications clusters. As part of its role as the Logistics Cluster lead, WFP is coordinating logistics services for the broader humanitarian response, developing common advocacy to address logistical challenges, facilitating humanitarian convoys and corridors, and establishing logistics bases to consolidate and prioritize humanitarian cargo deliveries. As of April 27, the Logistics Cluster had facilitated the movement of approximately 8,200 MT of humanitarian assistance for distribution to conflict-affected households in Ukraine since late February.

Meanwhile, State/PRM is supporting IOM and the Office of the UN High Commissioner for Refugees (UNHCR) to provide logistics support to the refugee response in neighboring countries.

FOOD SECURITY


To meet increasing food needs among conflict-affected individuals, WFP is scaling up operations to assist up to 6 million people in Ukraine and neighboring countries by June with USAID/BHA and other donor support. As part of this effort, USAID/BHA is funding WFP to procure and distribute more than 67,900 MT of in-kind food assistance to support approximately 1.3 million people and deliver HEBs sufficient for 239,000 people for five days in Ukraine.

Overall, with support from USAID/BHA and other donors, WFP reached approximately 3.3 million individuals with emergency food assistance and cash distributions between late February and early May. The UN agency also recently expanded food programming in conflict-affected locations near Ukraine's capital city of Kyiv, including Bucha town, where WFP reached nearly 2,000 individuals during the week of April 11.

USAID/BHA is also supporting Catholic Relief Services (CRS) to provide cooked meals to people in collective shelters in Moldova who have fled the war in Ukraine.

MULTIPURPOSE CASH ASSISTANCE

USAID/BHA supports IOM, WFP, and two INGOs, while State/PRM supports IOM, UNHCR, and an implementing partner, to provide MPCA to help conflict-affected individuals meet their basic needs. MPCA also enables households to meet shelter and winterization needs. USAID/BHA is supporting WFP to provide MPCA to nearly 317,000 people for three months across Ukraine, and the UN agency had reached more than 144,000 displaced people with MPCA as of April 27. Meanwhile, as of April 28, State/PRM partner UNHCR had enrolled more than 162,000 people in Chernivtsi, Dnipropetrovsk, Ivano-Frankivsk, Khmelnytskyy, Lviv, Ternopil, Vinnytsya, and Zakarpattya *oblasts* in its MPCA program and plans to enroll additional conflict-affected individuals in Cherkasy, Kirovohrad, Poltava, and Zaporizhzhya *oblasts* in the coming weeks.

State/PRM is also supporting IOM and UNHCR to provide MPCA to refugees in neighboring countries, as well as UNICEF to provide cash assistance to vulnerable households with children in transit. As of April 28, UNHCR had enrolled more than 37,700 people in Poland and nearly 28,800 people in Moldova in its MPCA program.

HEALTH

To support the health needs of conflict-affected populations, USG humanitarian partners are providing health kits, medicine, and other health assistance. USAID/BHA is supporting UNICEF, the UN World Health Organization (WHO), and two INGO partners to respond to emergency health needs in Ukraine. As of mid-April, USAID/BHA partner UNICEF had delivered five ambulances to children's hospitals in Lviv *Oblast*, with plans to deliver additional ambulances to children's and maternity hospitals in Chernihiv, Chernivtsi, Dnipropetrovsk, Kharkiv, Mykolayiv, Sumy, and Zaporizhzhya *oblasts*. The UN agency had also distributed medical supplies sufficient to treat nearly 835,000 people to health care facilities in Cherkasy, Dnipropetrovsk, Kharkiv, Kyiv, Lviv, Odesa, Poltava, and Sumy *oblasts*.


Meanwhile, USAID/BHA partner WHO had delivered more than 380 MT of life-saving medical supplies—including essential medicines, medical equipment, and supplies to treat traumatic injuries—to health facilities in Ukraine as of May 3, with a majority of commodities delivered to conflict-affected regions. Also with USAID/BHA support, WHO has delivered 10 interagency emergency health kits—sufficient to sustain the health care of up to 100,000 people for three months—and five trauma and emergency surgery kits, with combined medicines and supplies to support at least 500 surgical operations in emergency situations, into Kyiv.

State/PRM is supporting WHO to provide health assistance to refugees in neighboring countries. This includes meeting urgent trauma care needs and emergency health care by deploying emergency medical teams; providing trauma kits, essential medical supplies and equipment, and logistics support

to fill urgent gaps; extending access to coronavirus disease (COVID-19) services to refugee populations, including vaccinations; preventing and responding to vaccine-preventable diseases, such as measles and polio; providing mental health and psychosocial support to vulnerable populations and frontline health care workers; and preventing sexual exploitation and abuse.

In addition, State/PRM is supporting the UN Population Fund (UNFPA) in Hungary, Moldova, Poland, and Slovakia to increase health system capacity to absorb an increased refugee caseload through the deployment of mobile and static integrated community sexual and reproductive health (SRH) and gender-based violence (GBV) health units, supplies, and interventions to increase access to SRH and GBV prevention and response services. State/PRM is also supporting UNICEF in neighboring countries to scale up health support, including to prevent disease outbreaks and support infection prevention and control training. In addition, State/PRM is supporting IOM to provide primary health care consultations, mobile health and emergency services, and mobile psychosocial support teams.

WASH



USAID/BHA supports IOM, UNICEF, and four INGO partners to address WASH needs by conducting hygiene promotion activities, distributing essential hygiene items to vulnerable communities and social institutions, and conducting other WASH interventions. With support from USAID/BHA and other donors, UNICEF facilitated access to safe drinking water for nearly 409,000 people in Ukraine by augmenting water availability in collective sites, conducting water trucking services, and distributing drinking water between late February and late April. The UN agency also distributed WASH commodities to more than 86,000 people across Ukraine during the period.

In addition, USAID/BHA supports the WASH Cluster to provide humanitarian coordination and information management support, including sharing critical information with humanitarian partners regarding conflict incidents affecting WASH infrastructure and services. State/PRM partners are also conducting WASH activities among conflict-affected communities in Ukraine.

State/PRM is supporting UNICEF to provide WASH assistance to refugees in

PROTECTION

In response to increasing protection concerns among both populations in conflict-affected areas and those crossing from Ukraine into neighboring countries, USG partners are providing protection supplies and services. USAID/BHA supports UNICEF, WHO, and six INGOs to implement protection interventions for vulnerable populations. USAID/BHA partners provide psychosocial support services to children, persons with disabilities, and older people; operate mobile protection teams to reach remote communities; and conduct mine risk education activities to minimize protection risks. Furthermore, USAID/BHA is supporting UNICEF to deliver child protection supplies to support 40,000 people during their initial weeks of displacement in Ukraine.

In addition, State/PRM partners—including IOM, UNHCR, and UNICEF—provide protection and legal services to vulnerable individuals and are monitoring the impacts of ongoing hostilities. This includes through the establishment of Blue Dots, which are multi-agency facilities that provide one-stop protection services and social service referrals to new refugee arrivals in neighboring countries. As of April 28, State/PRM partners had established 19 Blue Dots reaching tens of thousands of people with protection services in Bulgaria, Italy, Moldova, Poland, Romania, and Slovakia.

In neighboring countries, State/PRM is providing protection support through IOM, UNFPA, UNHCR, and UNICEF, including GBV prevention and response, child protection, mental health, and psychosocial support; prevention and response to trafficking in persons; and establishment of child-friendly and women and girl-friendly spaces.

CONTEXT IN BRIEF

- The GoRF commenced widespread attacks against Ukraine on February 24 after months of gathering hundreds of thousands of military forces and heavy weaponry near its border with Ukraine. Immediately prior, the GoRF had ordered forces into Donetsk and Luhansk non-government-controlled areas after recognizing the areas' independence from Ukraine on February 21.
- On February 24, USAID announced the activation of a DART to lead the USG humanitarian response to
 the crisis in Ukraine, with staff in Rzeszów, Poland; Chişinău, Moldova; and Bratislava, Slovakia. To
 support the DART, USAID activated a Response Management Team (RMT) in Washington, D.C.
 State/PRM staff in Warsaw, Poland; Budapest, Hungary; Chişinău, Moldova; Bucharest, Romania;
 Bratislava, Slovakia; and Washington, D.C., also continue to support response activities.
- Since March 2014, the conflict in eastern Ukraine has caused large-scale population displacement and widespread damage to infrastructure. The heaviest fighting has occurred in the easternmost *oblasts* bordering Russia, particularly Donetsk and Luhansk; however, the large influx of IDPs from these areas has also affected neighboring *oblasts*. The UN estimated that 2.9 million conflict-affected people in eastern Ukraine required humanitarian assistance as of early 2022 prior to the GoRF invasion.
- On November 26, 2021, U.S. Chargé d'Affaires Kristina A. Kvien renewed the disaster declaration for Ukraine for FY 2022 due to widespread displacement and continued humanitarian needs of vulnerable populations in eastern Ukraine.

- USAID encourages cash donations because they allow aid professionals to procure the exact items needed (often in the affected region); reduce the burden on scarce resources (such as transportation routes, staff time, and warehouse space); can be transferred very quickly and without transportation costs; support the economy of the disaster-stricken region; and ensure culturally, dietarily, and environmentally appropriate assistance.
