

Somalia

Somalia's operational context remains challenging due to insecurity, political tensions, and a climate crisis that has pushed parts of central and southern Somalia at a risk of famine. In 2022, 1.4 million Somalis have been internally displaced due to drought and insecurity.

The formation of the new federal government finally culminated with the unveiling of 75- member Federal

However, deep rooted political differences between the federal and state governments threaten to undo hard-earned political gains.

The presence of armed actors and the escalation in armed-conflict continue to hinder humanitarian assistance to the most vulnerable.

UNHCR's operational footprint in Somalia dates back thirty years. Today, UNHCR is present in ten countrywide locations.

UNHCR provides protection and assistance to the refugees and asylum-seekers, internally displaced persons (IDPs), vulnerable host community members, and refugee returnees. The operation works closely with the Federal Government Somalia (FGS) and partners to support durable solutions for the persons UNHCR serves. Emergency response to conflicts and extreme climatic events are also central to UNHCR's mandate.



Working with Partners

In Somalia, UNHCR is delivering protection and assistance services through 28 partners that include 11 from the government, 10 national and local NGOs, and 7 INGOs. Furthermore, UNHCR also leads the Protection and Shelter Clusters and co-leads the CCCM Cluster.

Main Activities and Achievements

Refugees and Asylum-seekers

- Under its core mandate, UNHCR monitors the situation of refugees and asylum-seekers in Somalia, including the new arrivals, to ensure their adequate protection and well-being. Majority of refugees and asylum-seekers are from Ethiopia (68%) followed by Yemen and Syria (28%) and the remaining population are from other countries such as Syria and Tanzania. - UNHCR has trained 60 authorities on International Refugee Protection to strengthen
 the capacity of federal and state authorities to effectively operationalize domestic and
 international refugee legal instruments.
- UNHCR in 2022 has provided legal assistance, including counselling, representation before the court, mediation, and advocacy for release from custody to 4,313 individuals.
- UNHCR provides access to essential services, including education and healthcare, as well as material and financial assistance to the most vulnerable. In 2022, 24,475 individuals have received cash assistance to meet their basic needs; 7,530 individuals have benefited from primary and secondary health care services; 7,068 children have received education-material assistance; and 9,357 adolescent girls have received hygiene and sanitary materials.
- UNHCR assists refugees in Somalia to find durable solutions, such as local integration
 and resettlement to a third resettlement country. Since January 2022, the operation has
 processed 14 cases (62 individuals) for resettlement.

Somali refugee returnees

- Between 2014 and September 2022, UNHCR has assisted safe and dignified return of 93,175 Somali refugee returnees through the Assisted Spontaneous Return (ASR) programme, including 85,859 from Kenya and 5,566 individuals from Yemen, while smaller numbers of Somalis have also returned from other countries. In 2022 alone, UNHCR has supported 699 refugee returnees from Kenya and other countries. The latest data on refugee returnees can be accessed from the UNHCR Somalia data portal.
- The Assisted Spontaneous Return (ASR) programme from Yemen to Somalia resumed from late September, with the arrival of 150 Somali refugee returnees. The ASR programme between Yemen and Somalia was suspended because of the COVID-19 pandemic.
- UNHCR provides refugees returnees with a support package to facilitate their smooth reintegration in the community. This includes reintegration and subsistence cash



allowance, vocational training and business start-up grants, education, health, and other material assistance upon return. In 2022, **1,382** individuals have received re-integration cash, **144** children have received education grants to attend school, **163** individuals have received legal assistance, **183** have received skills training and business grant, and **480** have benefitted from transitional and emergency shelters.

IDPs

Drought and insecurity are the main triggers for internal displacement in Somalia. Due to the imminent risk of famine, the response for the internal displaced is largely centred around the drought response, which coordinated through various stakeholders including the authorities, international organizations, as well as national and international NGOs. UNHCR leads the inter-agency response in **Protection Cluster** and Shelter Cluster and co-leads the

CCCM Cluster. Food, livelihood, shelter, water, health, and non-food items (NFI) are often cited as the top priority needs by the IDPs.

- UNHCR Somalia has developed a "Vulnerability Assessment" (VA) tool to support a more granular level analysis of affected populations and to place the protection needs of women, children, elderly persons, and vulnerable groups at the centre of the scale-up to the drought response. UNHCR is working with other UN agencies to support enhanced inter-agency response.
- The PRMN (Protection and Return Monitoring Network) is a UNHCR-led project that reports on internal displacements, protection risks, and the triggers for such movements. The data is widely shared with other humanitarian partners for the drought response and is also used for IDP programming, advocacy, and external publication.
- UNHCR and partners provide shelter and NFI assistance, either in-kind or through cash grants, to IDPs and vulnerable host communities across the country. In 2022, more than 140,000 IDPs and host communities, including those who were affected by the drought, have received lifesaving NFI and shelter support.
- Following protection assessments, 3,526 IDPs have been supported with emergency protection cash assistance in 2022.
- Eviction and limited housing, land, and property (HLP) rights remain significant protection concerns in Somalia. UNHCR continues to support durable solutions and work closely with local authorities and IDPs to promote land tenure and local integration for IDPs.
- UNHCR's response for IDPs also include capacity building and awareness raising on prevention and response to gender-based violence (GBV), prevention of protection violations, and services available. In 2022, UNHCR has reached 160,982 individuals with awareness raising initiatives and 1,672 individuals with legal assistance.



Financial Information

Total recorded contributions for the Somalia Operation in 2022 amount to some US\$ 47.51 million. UNHCR is grateful for the critical support provided by donors who have already contributed to the Somalia Operation as well as those who have contributed to UNHCR programmes with unearmarked and broadly earmarked funds.
