STRATEGY on the Government Policy on Internal Displacement till 2025

General Overview

Military aggression by the Russian Federation against Ukraine, which has started in February 2014, as well as temprorary occupation of parts of Ukraine, have led to a large-scale internal displacement. A significant portion of these people were displaced and moved to the government-controlled territories and for 9 years haven't been able to return home as a result of destruction or damages of their property on the occupied territories or in war-affected areas. At the same time, accommodation issues, livelihood opportunities, recovery of their legal interests and rights remain a priority for many IDPs.

For a long time, the main focus of the state policy on internal displacement has been the integration of internally displaced persons at their new place of residence, which was achieved by removing obstacles to the exercise of their rights and fundamental freedoms, ensuring access to administrative, social, cultural and other services, as well as creating conditions for capacity development and strengthening the capacity of host territorial communities.

The next stage of the Russian Federation's armed aggression against Ukraine, which began on February 24, 2022, has posed new challenges to citizens and the state as a whole. Due to the full-scale invasion of the Russian Federation, there is a steady increase in the number of internally displaced persons, which is difficult to predict due to the unpredictability of military operations and acts of terror by the Russian Federation. Most of the measures taken by the state so far do not fully meet the current situation. At the same time, the priority in the policy of protecting the rights of internally displaced persons in the near future should be the adoption of short- and medium-term decisions aimed at implementing effective mechanisms to meet basic human needs and ensure access to services, strengthening the ability of communities to facilitate the adaptation of internally displaced persons and respond effectively to new challenges, rational use of community resources and budgets of all levels, as well as support for persons who intend to return to their places of residence.

The Strategy is aimed at improving the state policy in the field of internal displacement of Ukrainian citizens, foreigners, stateless persons who are legally staying in Ukraine due to the armed aggression of the Russian Federation against Ukraine, as well as the implementation by the state of all appropriate and available measures to solve problems and minimize the negative consequences associated with internal displacement.

The Strategy is an element of the short- and medium-term state policy aimed at creating conditions under which internally displaced persons, except for the most vulnerable categories, will not need special assistance or protection in connection with their displacement and will be able to fully enjoy their constitutional rights without any discrimination, including on the basis of origin or fact of internal displacement.

At the same time, the basic services provided for internally displaced persons should be provided with due regard for information and physical barriers for internally displaced persons of different categories, including persons with disabilities.

The development of the Strategy took into account the provisions of the Laws of Ukraine "On Ensuring the Rights and Freedoms of Internally Displaced Persons", "On the Principles of Domestic and Foreign Policy" and principles of international law, primarily international standards governing internal displacement, in particular the UN Guiding Principles on Internal Displacement, relevant recommendations and resolutions of the Committee of Ministers and the Parliamentary Assembly of the Council of Europe relating to the rights and freedoms of internally displaced persons, namely Resolution 2448 (2022) "Humanitarian consequences of the conflict in Ukraine". In preparing the Strategy, the Framework Program of the Inter-Agency Standing Committee on Durable Solutions for Internally Displaced Persons, established by the UN General Assembly resolution, was taken into account.

Key Issues, Caused by Internal Displacement

By February 24, 2022, the Unified Information Database on Internally Displaced Persons registered 1,470,072 such persons. One of the consequences of the armed aggression against Ukraine was the intensification of the displacement of people within and outside Ukraine. As of January 3, 2023, the number of registered internally displaced persons is 4,856,907, which does not fully correspond to the number of persons who have been internally displaced.

The reason for this discrepancy is, on the one hand, the state's policy of requiring internally displaced persons who have been registered to obtain a certificate of registration if they wish to have access to state guarantees and fully exercise their rights and freedoms (primarily the right to social protection and pensions). On the other hand, some citizens of Ukraine who have been internally displaced do not apply to the authorized bodies for registration as internally displaced persons, as they do not have such a need or do not currently associate such registration with meeting their needs.

At the same time, according to the International Organization for Migration, as of January 2023, the number of internally displaced persons in Ukraine was over 5.3 million. According to the United Nations High Commissioner for Refugees, as of the end of February 2023, the number of temporarily displaced Ukrainian citizens in Europe was over 8.1 million, of whom over 4.8 million were granted temporary protection or similar status. At the same time, the data of the United Nations High Commissioner for Refugees also includes Ukrainian citizens who were deported to the territory of the Russian Federation, and, according to the UNHCR, is mainly based on information provided by the Russian Federation.

According to the report "Rapid Assessment of Damage and Recovery Needs - August 2022" prepared by the World Bank, the Government of Ukraine and the European Commission, it is estimated that 2.5-3 million people who left Ukraine for the EU may not return regardless of of the military situation. At the same time, according to the Government of Ukraine, about 1.2 million people, including 211,000 children, were forcibly deported to the Russian Federation and may not be able to return.

The conditions under which a significant number of people were internally displaced before February 24, 2022, and an even larger number after the outbreak of the full-scale armed aggression against Ukraine, create difficulties in developing a balanced state policy covering all groups of internally displaced persons, in particular, first response measures and social support for such persons in the first months after displacement.

The large-scale aggression against Ukraine and the risk of its further escalation, the destruction of the infrastructure of settlements, both those close to the combat zone and those already undergoing hostilities, and those located in other parts of the country, create risks of a significant increase in internal displacement. The state's announcement of mandatory evacuation from certain regions or parts of them, including the evacuation from Donetsk Oblast that began in the summer of 2022, implies that the state will assume responsibility for planning the departure, ensuring its implementation, accommodating people and meeting their primary basic needs.

As a result of the armed aggression against Ukraine since February 24, 2022, at least 135,800 residential buildings have been destroyed or damaged, including 119,900 private houses, 15,600 apartment buildings and 0,200 dormitories. The issue of providing housing for internally displaced persons is becoming increasingly relevant. At the same time, assessing the real needs and capacities of communities to ensure access to housing is significantly complicated due to the lack of a systematic mechanism for such assessment and the scale of the problem. Local housing funds are limited or non-existent, and the mechanism for attracting local investment needs to be improved. These problems need to be addressed both in the context of responding to internal displacement and in the development of a state policy aimed at addressing a wide range of housing issues, including the establishment of a legal mechanism for the long-term protection of the housing rights and interests of persons affected by the armed aggression against Ukraine.

Internally displaced persons need substantial support from host communities, especially at the stage of adaptation after displacement, as well as further integration. Assessing the needs of internally displaced persons and identifying opportunities to meet them should be an important element of the state policy on internal displacement.

At the same time, given the challenges posed by the armed aggression against Ukraine to legal entities (relocation of enterprises, institutions and organizations of all forms of ownership, reformatting activities, search for new markets, preservation and creation of new jobs, etc.), the issue of relocation of legal entities requires separate regulation at the state level.

The Objective and Principles of the Strategy

The purpose of the Strategy is to reduce the impact of the negative consequences of internal displacement caused by the armed aggression against Ukraine on Ukrainian citizens, foreigners and stateless persons who are legally on the territory of Ukraine by introducing comprehensive and effective mechanisms of state response to challenges that arise from the moment a person decides to move, during his or her social adaptation and integration in the host community, as well as in the case of a person's voluntary return to the abandoned place of residence and re-entry.

According to the Ministry of Economy, in 2022, at the expense of funds provided under the program of providing compensation to employers for labor costs for the employment of internally displaced persons in accordance with the Procedure for providing compensation to employers for labor costs for the employment of internally displaced persons as a result of hostilities during martial law in Ukraine, approved by the Resolution of the Cabinet of Ministers of Ukraine of March 20, 2022, No. 331 (Official Gazette of Ukraine, 2022, No. 44, p. 2394), almost 16.5 thousand internally displaced persons were employed.

The strategy is based on the following principles:

- rule of law;
- Respect and protection of human rights in the context of internal displacement, taking into account the norms and standards of international law and the practice of the European Court of Human Rights;
- non-discrimination on any grounds;
- ensuring information and physical barrier-free access to services for internally displaced persons of different categories, including persons with disabilities;
- good governance;
- ensuring equal rights and opportunities for women and men in all spheres of society;

- combating violence in the context of internal displacement, including gender-based violence;
- family reunification;
- engaging the potential of internally displaced persons for the development of host communities;
- support for self-organization of internally displaced persons; openness and transparency of the Strategy implementation in order to maximize the involvement of all stakeholders in its implementation and monitoring;
- specificity, achievability of goals and measurability of the expected results of the Strategy implementation;
- Ensuring constructive interaction between internally displaced persons, host communities, local state authorities and local self-government bodies;
- making appropriate decisions based on data on the needs of internally displaced persons;
- facilitating the involvement of internally displaced persons in the process of formulating and implementing state, regional and local policies;
- Adaptation and integration of children and youth from among internally displaced persons into the social environment in the territory of their residence;
- voluntary return of a person to the abandoned place of residence;
- delimitation of powers of state authorities and local self-government bodies of different levels in the implementation of the Strategy;
- encouraging internally displaced persons of working age to find employment and start their own business in order to ensure their
- economic independence;
- differentiating support tools for internally displaced persons depending on their needs.

Strategic Goals and Solutions

The objectives of the Strategy are based on an assessment of the challenges associated with the process of internal displacement as a result of armed aggression against Ukraine and the results of the implementation of short- and medium-term solutions to internal displacement.

Strategic objective 1. Strengthening the state's capacity to respond to the challenges of internal displacement and ensuring conditions for the implementation of the state policy on internal displacement.

The large-scale armed aggression has significantly affected the processes of internal displacement, causing a significant increase in the number of internally displaced persons and the need to change the mechanisms of the state's response to the simultaneous processes of evacuation, adaptation and integration, return of people and family reunification. Thus, there is a need to update the Law of Ukraine "On Ensuring the Rights and Freedoms of Internally Displaced Persons" and other laws, taking into account the necessary measures, international practice and experience in responding to large-scale internal displacement, including the medium- and long-term needs for effective remedies and justice.

Today, state and local authorities, as well as international nongovernmental organizations and public associations, operate with data obtained using their own methodology, available resources and sources. The state, represented by its authorized bodies, does not fully possess verified data on the affected population and territorial communities in terms of various spheres of life. The appeals received by the contact centers of the state authorities are not properly summarized, which affects the efficiency of response to the problems arising from internal displacement and complicates the prompt satisfaction of the needs of internally displaced persons. The measures envisaged by the Strategy are aimed at meeting the needs of internally displaced persons of different categories.

In order to ensure the development and implementation of the state policy on internally displaced persons, promote the exercise of their rights and freedoms and create conditions for the voluntary return of such persons to their abandoned place of residence or integration at a new place of residence, the functions and powers of the responsible state authorities need to be updated and enshrined in legislation.

The main tasks required to solve these problems are:

- Updating the legislation on internal displacement;
- Improvement of the Unified Information Database on Internally Displaced Persons, its integration with other databases and state registers;
- introducing a system of periodic needs assessment of internally displaced persons, including the possibility of collecting disaggregated data.

The key indicators of the Strategy's effectiveness are as follows:

- development and introduction of amendments to the Law of Ukraine "On Ensuring the Rights and Freedoms of Internally Displaced Persons" and other laws to ensure the realization of the rights of internally displaced persons;
- Ensuring the finalization and integration of the Unified Information Database on Internally Displaced Persons with relevant databases and public electronic registers;

- establishing a coordination mechanism to coordinate the actions of state bodies, local governments, international partners and public associations aimed at providing assistance and meeting the needs of internally displaced persons;
- introducing a mechanism for collecting data and assessing the needs of internally displaced persons for the purpose of further meeting them, taking into account the vulnerability criteria;
- introduce an electronic cabinet of internally displaced persons by improving the Unified Information Database on Internally Displaced Persons.

Strategic objective 2. To create conditions for the safe movement of people from settlements located in the area of military (combat) operations and meet their humanitarian needs.

The large-scale armed aggression against Ukraine has led to a massive exodus and evacuation of residents of settlements located in the areas of hostilities or in the temporarily occupied territories. Starting from February 24, 2022, 165 humanitarian corridors were organized, which evacuated more than 350 thousand civilians in March-May. In addition, about 170 thousand people were evacuated from dangerous areas as part of the work of coordination centers for the evacuation of civilians.

In the midst of mass evacuation, the issue of state support (development of community infrastructure, expansion of public services, increase in housing stock, etc.) is relevant for host communities, as community resources are limited. The evacuation of civilians should be safe, and the peculiarities of evacuation and the needs of persons with disabilities and other low-mobility groups should be taken into account.

Immediately after displacement, internally displaced persons need support from host communities, which begins with a request for humanitarian assistance. At this stage, the issue of proper interaction between humanitarian aid providers is acute, given the actual lack of leadership from the state authorities in coordinating the provision and distribution of humanitarian aid.

The main tasks required to solve these problems are:

- introducing a protocol for intersectoral cooperation, including with international and non-governmental national organizations, on the preparation, organization and implementation of mass displacement of persons during armed conflict, including mandatory evacuation;
- ensuring coordination by the state of the process of mass displacement of persons during armed conflict, including mandatory evacuation;

- ensuring full and proper notification about the evacuation, its stages, components, consequences, rights and obligations during the evacuation, as well as about further support measures from the state and host territorial communities;
- coordinating the provision of humanitarian assistance to persons evacuated from settlements where hostilities are taking place or may take place;
- introducing systematic support for the communities to which evacuation is carried out.

The key performance indicators are:

- adoption of regulations to implement a protocol for preparing, organizing and conducting evacuations, including mandatory evacuations; Arrangement of technical means for transportation of persons with disabilities and other low-mobility groups;
- organizing and conducting an information campaign taking into account accessibility requirements, aimed at explaining key issues related to evacuation and further support of evacuees by the state and host territorial communities;
- establishing a national Coordination Headquarters and a system of local evacuation headquarters to ensure coordination of evacuation processes, including mandatory evacuation, as well as provision of humanitarian assistance to evacuees.

Strategic objective 3. Facilitate the adaptation of internally displaced persons at their new place of residence immediately after internal displacement.

The significant increase in the number of internally displaced persons and the expansion of the list of needs depending on the period of displacement require improved approaches and efforts to support host communities in order to develop effective mechanisms of social adaptation that create conditions for the further successful integration of internally displaced persons at their new place of residence.

Provision of various types of assistance and access to services for internally displaced persons is often linked to the need to register them. The current system does not provide for assistance to persons during the adaptation period and does not distinguish between needs that arise immediately after internal displacement, as part of the adaptation process, and during integration in new territorial communities.

The main need of internally displaced persons after displacement is to provide a place for temporary residence (stay). The lack of a sufficient number of residential or other premises suitable for temporary accommodation of internally displaced persons leads to the fact that such persons decide to go abroad or return prematurely to their abandoned place of residence. At the same time, since the beginning of the large-scale armed aggression against Ukraine, the number of places of compact settlement of internally displaced persons has increased significantly. Given the mostly inadequate living conditions in such places, there is a need to develop and approve a State Targeted Program for the provision of housing for internally displaced persons.

In addition, the issue of determining the public authorities responsible for controlling the creation and functioning of places of compact settlement of internally displaced persons needs to be resolved at the legislative level. At the same time, the issue of forming a unified information base of residential and other premises suitable for temporary residence (stay) of internally displaced persons, introducing clear mechanisms for the realization of housing rights of internally displaced persons, the right to an adequate and decent standard of living with an assessment of available and possible resources, including financial ones, remains problematic.

After the outbreak of large-scale armed aggression against Ukraine, approaches to the allocation of housing assistance to internally displaced persons have been changed, but they still do not fully take into account the needs of such persons, in particular, assistance is allocated without time limits and without additional conditions for assessing the property status of internally displaced persons.

Host territorial communities face an additional financial burden due to the need to increase expenditures without a corresponding increase in revenues. Low motivation for employment, retraining, and starting a business leads to increased dependence of internally displaced persons on state support and a shortfall in tax revenues for host communities.

The current mechanisms for providing social and pension benefits to internally displaced persons (including those who were displaced before February 24, 2022) do not comply with the general approaches to their provision to other categories of Ukrainian citizens, create an additional burden on internally displaced persons and social protection authorities, and lead to extended delays in the appointment and payment of benefits. For example, the appointment (renewal) of pensions to persons who have moved from the Autonomous Republic of Crimea and the city of Sevastopol requires the request for a pension file from the authorized bodies of the Russian Federation. In addition, persons who were displaced before February 24, 2022, cannot choose a bank to receive their pensions and are forced to use the services of JSC Oschadbank exclusively, and a separate debt repayment procedure applies to them. In turn, the procedure for making social payments provided for internally displaced persons applies to persons who have refused to receive a certificate of registration and have registered/declared their place of residence in the territory controlled by the Government of Ukraine. A separate mechanism for monitoring compliance with the requirements of the law in the course of providing

assistance has been introduced for internally displaced persons, which provides for random inspections of the actual place of residence (stay).

The insufficient level of available psychological assistance and rehabilitation for internally displaced persons, especially children affected by the armed aggression against Ukraine, complicates the process of adaptation in the new environment, including the educational one. In addition, it is equally important to create conditions for organizing psychosocial support at a new workplace for internally displaced persons.

At the local level, the issue of attracting resources to implement adaptation measures for internally displaced persons is relevant. Host communities need assistance in finding resources and appropriate funding from the state. In addition, it is important to ensure access to reliable and up-to-date information on available services and places for temporary accommodation of internally displaced persons. The basic services to be provided to internally displaced persons should comply with the principle of information and physical barrierfree access. In order to establish a dialogue between internally displaced persons and the population of host territorial communities, it is necessary to conduct joint educational, social, cultural, training and other activities, as well as information campaigns aimed at peaceful coexistence, promotion of social cohesion and integration.

An important component that will facilitate the adaptation process of internally displaced persons and the formation of healthy social communications between different groups of the population is integration into the cultural and sports space of host communities.

The main tasks required to solve these problems are:

- creating conditions and providing support to host communities to meet the basic needs of internally displaced persons;
- ensuring social adaptation of internally displaced persons at the initial stage after evacuation;
- phased resettlement of internally displaced persons from places of compact settlement, taking into account the criteria of vulnerability, gender and the principle of family unity;
- creating conditions for psychological assistance and rehabilitation of internally displaced persons, including children;
- creating conditions for the organization of psychosocial support in the workplace for internally displaced persons who have found employment at a new place of residence;
- creating a system of timely provision of reliable and up-to-date information on available services and places for temporary accommodation of internally displaced persons in accessible formats;

- involvement of internally displaced persons in the cultural life of territorial communities and access to cultural services;
- ensuring access to educational services for internally displaced persons; involving internally displaced persons in physical activity and sports as a means of mental and physical health;
- introducing preferential terms for calculating rent for state property for local governments, utilities, institutions and organizations that are fully or partially financed from the local budget and whose scope extends to the temporarily occupied territory, the territory under encirclement (blockade) and areas of military (combat) operations, as well as those that lease state property for the arrangement of dormitories for temporary residence of internally displaced (evacuated) persons whose housing was destroyed or damaged
- phased resettlement of internally displaced persons from places of compact settlement, taking into account the criteria of vulnerability, gender and the principle of family unity.

The key performance indicators are:

- ensuring the provision of social services to internally displaced persons based on their individual needs;
- introducing a social service "assistance in adaptation of internally displaced persons" for persons in difficult life circumstances and approving the relevant standard for its provision;
- implementation of a phased resettlement of internally displaced persons from places of compact settlement, taking into account the criteria of vulnerability, gender and the principle of family unity;
- ensuring psychological assistance to internally displaced persons, including children, and their rehabilitation;
- ensuring that internally displaced persons are informed on issues related to the realization of their rights using various resources in an accessible format.

Strategic objective 4. Facilitate the integration of internally displaced persons by creating conditions for capacity development and strengthening the capacity of host communities.

The transition from social adaptation to creating conditions for capacity development and strengthening the capacities of host territorial communities should contribute to the conclusion of the process of integration of internally displaced persons into the host community. The purpose of integration is to achieve conditions under which internally displaced persons will be able to fully enjoy their constitutional rights and freedoms, as well as to fulfill their duties without any discrimination, including on the basis of internal displacement. The lack of reliable statistical data on the number of internally displaced persons and their needs leads to a mismatch between the integration measures implemented and actual needs. As a result, the established discriminatory practice of access to certain services for internally displaced persons, and the exercise of rights not related to internal displacement on the basis of a certificate of registration of internally displaced persons has led to an artificial increase in the number of registered internally displaced persons. At the same time, some displaced persons did not apply to the authorized bodies for registration. The large-scale armed aggression against Ukraine has led to a significant increase in the need for housing programs and financial instruments that can provide the affected population, including internally displaced persons, with access to housing.

The slowdown in economic growth and the lack of jobs have led to an increase in the number of internally displaced persons in difficult life circumstances and, accordingly, increased the burden on the infrastructure and budgets of territorial communities.

Different levels of capacity to implement measures for the integration of internally displaced persons at the local level, social cohesion in territorial communities, and the lack of a clear mechanism for assessing the needs of internally displaced persons at the local level lead to the unwillingness of some host territorial communities to fully implement such measures.

The main tasks required to solve these problems are:

- introducing a mechanism for periodic monitoring and evaluation of the state of integration of internally displaced persons into host communities;
- creating conditions for the social integration of children affected by the armed aggression of the Russian Federation against Ukraine;
- Implementation of measures for vocational training/retraining, support for employment and self-employment of internally displaced persons, including through the implementation of relevant non-governmental projects and support programs;
- Creating housing funds for temporary residence of internally displaced persons in order to meet medium-term needs in each territorial community;
- providing internally displaced persons with affordable housing, taking into account their needs, capacities and vulnerability criteria;
- expanding the list of credit and investment mechanisms for providing housing for internally displaced persons with large-scale donor support;
- strengthening interregional cooperation to implement programs and activities, in particular for youth, aimed at promoting social cohesion, strengthening national unity through dialogue and joint actions;

- support for the establishment of advisory bodies to involve internally displaced persons in the decision-making process of local executive authorities and local self-government bodies;
- taking measures to ensure the sustainability of territorial communities and their cohesion with the involvement of internally displaced persons;
- creating housing funds for temporary residence of internally displaced persons to meet medium-term needs in each territorial community.

The key performance indicators are:

- periodic monitoring and evaluation of the integration of internally displaced persons into host communities;
- Reducing the number of unemployed internally displaced persons;
- Providing internally displaced persons with housing from the housing funds for temporary residence, under preferential long-term lending programs, taking into account vulnerability criteria;
- increase the amount of financing under credit and investment mechanisms for providing internally displaced persons with housing at the expense of state and local budgets and other sources not prohibited by law;
- establishment and functioning of advisory bodies on issues related to internal displacement at the local level;
- ensuring equal access to opportunities for creative development, quality leisure and cultural rights of internally displaced persons in territorial communities, as well as strengthening social cohesion and their full integration.

Strategic Objective 5: Support for the safe return to the place of origin and reintegration of internally displaced persons.

An important element of the implementation of the state policy on internal displacement is the support by state authorities and local self-government bodies for the voluntary safe return of Ukrainian citizens to their territorial communities after the de-occupation of the respective territories or the cessation of active hostilities.

The lack of up-to-date information, including on the current security situation, response measures, the state of critical and social infrastructure, educational and healthcare facilities, and the state of the environment, makes it difficult for internally displaced persons to make a decision to return to their place of residence.

The state should facilitate the voluntary and safe return of internally displaced persons to their places of origin or their resettlement to another region. At the same time, it is necessary to take measures to rebuild destroyed housing, as well as reconstruct and repair damaged housing and other real estate, or to introduce procedures for compensation for housing destroyed or damaged as a

result of hostilities as a secondary way of compensating for violated property rights.

The mechanism of intersectoral cooperation in responding to securityrelated risks (the need for demining, construction of shelters, etc.) and restoration of critical and social infrastructure needs to be improved. It is necessary to take measures to respond to possible tensions and conflicts in territorial communities caused by the current situation.

The main tasks required to solve these problems are:

- Ensuring intersectoral cooperation between state authorities and local selfgovernment bodies to formulate a state policy on returning to the place of residence and reintegration of internally displaced persons;
- introducing a procedure for accounting and compensation for the value of destroyed and/or damaged property;
- ensuring proper information and creating other conditions for internally displaced persons to make an informed decision to return to their abandoned place of residence;
- ensuring proper planning for the restoration of regions and territories affected by the armed aggression against Ukraine;
- assistance in implementing measures to increase cohesion and overcome conflicts;
- Implementation of information activities aimed at integrating internally displaced persons in host communities;
- creating the basis for restoring the damaged infrastructure of de-occupied settlements.

The key performance indicators are:

- introduction of a mechanism for coordinating the activities of state authorities and local self-government bodies in addressing the return of internally displaced persons to their places of origin and their reintegration;
- regular informing of the population, including through official web portals of the state authorities and territorial communities, on the situation in the settlements from which the internal displacement was carried out;
- the number of destroyed or damaged housing that has been rebuilt and repaired in the territorial communities;
- the number of territorial communities that use digital platforms to map the housing destroyed and damaged as a result of the armed aggression against Ukraine and its restoration at the level of the territorial community;

- the number of internally displaced persons who have found employment in the territory of residence;
- development and adoption of local programs to increase cohesion and overcome conflicts.

Expected Results of the Strategy Implementation

The expected results at each stage, including the planned timeframe for achieving the targets and the estimated amount of financial, logistical, human and other resources required, are set out in the Operational Plan for the implementation of the Strategy for a three-year period.

The implementation of the Strategy will result in improving the quality of life of internally displaced persons by strengthening their capacities and social resilience, stimulating economic activity, ensuring the exercise of their rights and fundamental freedoms, and ensuring voluntary, dignified and safe return to the place of origin, among other things:

- introduction of a systemic state policy on internal displacement; creating conditions for the safe movement of people from dangerous areas and meeting their humanitarian needs;
- facilitating the adaptation of internally displaced persons at their new place of residence;
- Integration of internally displaced persons by removing obstacles and creating conditions for the development of their potential, strengthening the capacity of internally displaced persons in host territorial communities;
- creation of conditions under which internally displaced persons have the opportunity to return to their places of residence in a safe and dignified manner;
- Ensuring the reintegration of internally displaced persons into public life upon returning to their abandoned place of residence; providing support to territorial communities to create conditions for accepting internally displaced persons and their return to the place of origin, including through the use of incentives.

Procedure for Monitoring and Evaluation of the Results of the Strategy Implementation and Reporting

Monitoring and evaluation of the results of the Strategy implementation are carried out within the powers of the Cabinet of Ministers of Ukraine, the Ministry of Reintegration, other central executive authorities with the participation of public associations and business associations, and international organizations. As part of the monitoring, it is planned to prepare and submit to the Cabinet of Ministers of Ukraine information on the status of implementation of the Strategy's tasks and measures.

The effective implementation of the action plan for the implementation of the Strategy will be ensured by using appropriate tools for monitoring key performance indicators and strengthening the institutional capacity of central executive authorities.

Financial Support for the Strategy Implementation

The sources of funding for the Strategy implementation are the state and local budgets and other sources not prohibited by law.

Financial support for the implementation of the Strategy will also be provided through financial and technical assistance provided to Ukraine by international organizations and foreign countries. Technical assistance may be provided in the form of expert assistance, necessary material resources or funds allocated for targeted needs.

The amount of expenditures required for the implementation of the Strategy is determined annually when drafting the state and local budgets for the respective year, taking into account their real capabilities.

The distribution of financial resources to achieve the results should be based on the principle of balance both in the humanitarian and recovery and development areas.
