


Place of intended return (Top 5)




Reasons for leaving Pakistan(Push Factors)^(c)



Place of Residence in Pakistan




Reasons for return to Afghanistan (Pull Factors)^(c)






BREAKDOWN BY ETHNICITY



MONTHLY VOLUNTARY REPATRIATION TRENDS (2023-2024)


